## <u>O P I N I O N</u>

Errol D. Rohrberg, an individual, requests a permit to operate as a dump truck carrier in the Counties of Fresno, Kern, Monterey, Santa Barbara, and San Luis Obispo. His principal place of business is at Stockdale and Huey Roads, San Luis Obispo, CA 93446. Rohrberg currently holds vacuum truck carrier and heavy specialized carrier permits and a highway common carrier certificate under File T-90,484. Notice of the filing of the application appeared in the Commission's Daily Calendar of June 29, 1981. Rohrberg served a copy of his application on a number of persons with whom the proposed service is likely to compete. California Dump Truck Owners Association and California Trucking Association were also served. No protest has been received.

As of May 15, 1981, Rohrberg's balance sheet shows total assets of \$940,184 and a net worth of \$596,135. He shows a 45 days' working capital requirement of \$6,097 and liquid assets of almost \$35,000. Rohrberg certifies that he has resided in California for not less than 90 days next preceding this filing. He has two end-dump trucks. King City Transit Mix, Greenfield, submitted a certificate in support of the application.

## Findings of Fact

1. Rohrberg is a fit and proper person to receive a permit as a dump truck carrier and possesses sufficient operating knowledge and financial ability to perform the proposed operation.

2. Rohrberg's equipment will not endanger the safety of highways or impair the condition or maintenance of them either directly or indirectly.

3. Rohrberg's proposed operation will not unnecessarily burden the public highways, is necessary to serve the public, and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.

Rohrberg has been a California resident for not less than
90 days next preceding this filing.

5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

6. The following order complies with the guidelines of the Commission's Energy Efficiency Plan. <u>Conclusion of Law</u>

Rohrberg should be granted a dump truck carrier permit authorizing operations within and between all points in the Counties of Fresno, Kern, Monterey, Santa Barbara, and San Luis Obispo. The effective date of the following order should be the date of signature to be consistent with the issuance of permits to other classes of carriers.
