O P I N I O N

Terry Paul Ryerson, doing business as Terry Ryerson Trucking (Ryerson), seeks issuance of a cement contract carrier permit. Ryerson presently has a highway contract carrier permit. Copies of the application were served on carriers with which the proposed service is likely to compete and on the California Trucking Association. Notice of the filing of the application appeared in the Commission's Daily Calendar of July 1, 1981. No protest to the application has been received.

Ryerson's business location is at 2251 Cross Road, El Centro, CA 92223. His operating equipment consists of one tractor, a semitrailer, and a pull-trailer. The two trailers are cement gravity hoppers. Ryerson proposes to operate under this permit in Imperial and San Diego Counties.

Ryerson's total assets amount to \$188,510, with a net worth of \$88,010. The application has attached an agreement between Ryerson and Owl Rentals, doing business as Rynel Transit Mix, for the hauling of bulk cement.

Findings of Fact

1. Applicant is a fit and proper person to receive a permit as a cement contract carrier and possesses sufficient operating knowledge and financial ability to perform the proposed operation.

2. Ryerson has resided in California for more than 90 days preceding the filing of the application.

3. Ryerson's equipment will not endanger the safety of highways or impair the condition or maintenance of them either directly or indirectly.

4. Ryerson's proposed operation will not unnecessarily burden the public highways, is necessary to serve the public, and will not impair the ability of presently permitted cement contract carriers to provide adequate service at the lowest possible reasonable rates.

5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

6. The following order complies with the guidelines in the Commission's Energy Efficiency Plan.

Conclusion of Law

Ryerson should be granted a cement contract carrier permit authorizing operations within and between all points in the counties of Imperial and San Diego. The effective date of the following order should be the date of signature to be consistent with the issuance of permits to other classes of carriers.

O R D E R

IT IS ORDERED that upon applicant's compliance with the Commission's General Order Series 100, the Executive Director shall issue a cement contract carrier permit to Terry Paul Ryerson authorizing operations within and between all points in the counties of Imperial and San Diego.

This order is effective today.
