O P I N I O N

By this application, as amended, Conti Trucking, Inc. (Conti), a highway common carrier, seeks authority to have the Westcoast Motor Tariff Bureau, Inc. publish certain changes in its Local and Joint Freight No. 1, Cal. P.U.C. No. 3 for its account.

The changes will result in increases on certain traffic. Conti has detailed its increased cost accruing on this traffic. The cost data support Conti's need for the additional revenues. Further changes are sought which would correct an item number and update a listing of foodstuffs and related items transported to grocery stores and grocery store suppliers. The resulting increase will not increase Conti's gross California intrastate revenue by as much as 1%.

The application and amendment were listed on the Commission's Daily Calendars of August 13 and 27, 1981, respectively. No objection to the granting of the application as amended has been received.

Findings of Fact

1. The increase and changes resulting from this proposal are justified.
2. The following order has no reasonably foreseeable impact on the energy efficiency of highway carriers.
3. A public hearing is not necessary.

Conclusion of Law

The proposed changes are justified and should be granted as set forth in the order.

O R D E R

IT IS ORDERED that:

1. Conti Trucking, Inc. is authorized to have published in the Westcoast Motor Tariff Bureau, Inc. Local and Joint Freight Tariff No. 1, Cal. P.U.C. No. 3 the amendments as specifically proposed in the application as amended.
2. Tariff publications authorized to be made as a result of this order shall be filed not earlier than the effective date of this order and may be made effective not earlier than 5 days after the

effective date of this order on not less than 5 days' notice to the Commission and to the public.

3. The authority granted shall expire unless exercised within 90 days after the effective date of this order.

This order becomes effective 30 days from today.
