ORDER EXTENDING TEMPORARY CERTIFICATE

In Decision (D.) 93161 we issued Pacifico Creative Service, Inc. (Pacifico) a temporary passenger stage certificate (corrected for certain clerical errors by D.93467 dated September 1, 1981).

By our orders in D.93161 and D.93467, the authority granted expired on October 31, 1981, unless extended by further order.

While we have previously stated that further extension of this temporary authority is undesirable, we now have before us proposed decisions in this application and also in Applications 59818 et al., in which numerous factual and legal problems are presented. We need adequate time to consider these issues in an orderly manner, and our inability to decide these matters finally on or before October 31 is no fault of the parties to the proceeding.

The second Commission conference of November is scheduled for Friday, the 13th. In order not to interrupt public service, we will extend Pacifico's temporary authority until that date.

Our willingness to extend Pacifico's temporary certificate should not be viewed as a predetermination of any issues to be decided in our final opinion and order.

Finding of Fact

The numerous legal and factual issues presented to us in the proposed final decision in this application require additional time for our consideration.

Conclusion of Law

The expiration date of Pacifico's temporary certificate should be extended to November 13, 1981, and since there is no Commission conference between now and October 31, 1981, this special order is necessary.

IT IS ORDERED that the temporary passenger stage certificate of public convenience and necessity granted to Pacifico Creative Service, Inc. in D.93161, as modified in D.93467, is extended to and including November 13, 1981.

This order is effective today.
