BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the matter of the application of Kathy (sic) Branden for certificate of public convenience and necessity to operate The Pine and The Palm Tour Service between the City of Santa Barbara, California and Solvang, California and various points of interest in between.

Application 60630 (Filed June 5, 1981)

<u>OPINION</u>

Kathryn Branden (applicant), doing business as The Pine and The Palm Tour Service, seeks a certificate of public convenience and necessity to operate as a passenger stage corporation to transport passengers "on-call" for sightseeing tours between hotels/motels in the Cities of Santa Barbara, Goleta, and Montecito, on the one hand, and points of interest in the City and County of Santa Barbara, on the other hand.

Applicant proposes to offer seven towns of the Santa Barbara County area as follows:

Tour 1 - Mountain Hideaway Adventures

Tour to San Marcos Pass, Los Padres National Forest, and Santa Ynez.

Tour 2 - Santa Barbara Beach and City Tour

Tour to the Santa Barbara Rivlera, Hope Ranch, and Montecito.

Tour 3 - Red Rock Wilderness Excursion

Towns to Los Padres National Forest.

Tour 4 - Solvang

Tour to San Marcos Pass, Los Padres National Forest, and Solvang.

Tour 5 - Seven Falls Adventure

Tour to Tunnel Road hiking trail in Los Padres National Forest.

Tour 6 - Figueroa Mountain Express

Tour to San Marcos Pass, Los Padres National Forest, and the Figueroa Mountain Range.

Tour 7 - Santa Barbara Botanic Gardens and Scoffield Park, Santa Barbara

Tour to the Santa Barbara Botanic Gardens and Scoffield Park, Santa Barbara.

A description of the proposed tours and the time schedules along with the intended tariff and its rules are contained in Exhibit A of the application.

A map describing routes is shown in Exhibit B of the application.

Applicant states that she plans to purchase a late model Ford 10-passenger van to be used in providing the service.

A statement of financial condition outlined in the application shows applicant's net worth of \$17,200. Applicant alleges that public convenience and necessity require granting of the authority sought for the following reasons:

- a. The proposed service is not offered by any other carrier in the area where applicant will conduct the towns.
- b. The service is especially unique in character which applicant believes will offer a special attraction to out-of-town visitors and local residents.
- c. Applicant claims to have historical knowledge regarding the areas she proposes to serve and plans to narrate the history which she implies will enhance the tour to the benefit of participants.

Applicant asserts that the proposed service will not have an adverse impact upon the environment but instead will reduce traffic congestion, smog, and energy consumption because the service will offer a larger passenger-carrying vehicle alternative to use of the private automobile.

The application was listed in the Commission's Daily Calendar on June 10, 1981, and copies of the application were served on the City and County of Santa Barbara and Greyhound Lines, Inc. (Greyhound). On July 2, 1981, W. A. Martin, manager, Operating Rights and Commerce for Greyhound, wrote that on June 29, 1981 he held a telephone conversation with applicant during which he conveyed the facts and terms of restrictions which, if included in the proposed service, would satisfy Greyhound's interest in her application. A copy of an attached letter dated June 29, 1981 from applicant to the Commission requested that any grant of authority to Application (A.) 60630 be restricted as follows:

- 1. Only one-day, on-call, round-trip sightseeing tours to be conducted.
- 2. Tours to Solvang would be restricted to the operations of no more than two hours per week, with no more than one tour operated per weekend.

An original copy of the above letter was received at the Commission in San Francisco, time-stamped on July 31, 1981.

There has been no other objection to the application.
Findings of Fact

l. Applicant seeks a certificate of public convenience and necessity to operate as a passenger stage corporation to transport passengers on-call for sightseeing tours between hotels/motels in the Cities of Santa Barbara, Goleta, and Montecito, on the one hand, and points of interest in the City and County of Santa Barbara, on the other hand.

- 2. Applicant possesses the management ability and financial resources to perform the proposed service.
- 3. Public convenience and necessity require that applicant's proposed service be certificated.
 - 4. There are no protests to the application.
- 5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

Conclusions of Law

- 1. The Commission concludes that A.60630 should be granted as set forth in the ensuing order.
- 2. The following order should be effective on the date of signature since there is a demonstrated present need for applicant's service.
 - 3. A public hearing is not necessary.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

- 1. A certificate of public convenience and necessity is granted to Kathryn Branden, doing business as The Pine and The Palm Tour Service, authorizing her to operate as a passenger stage corporation, as defined in PU Code Section 226, between the points and over the routes set forth in Appendix A, to transport persons.
 - 2. Applicant shall:
 - a. File a written acceptance of this certificate within 30 days after this order is effective.
 - b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.

- c. State in her tariffs and timetables when service will start; allow at least 10 days' notice to the Commission: and make timetables and tariffs effective 10 days or more days after this order is effective.
- d. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.

This order is effective today.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Kathryn Branden, an individual, doing business as The Pine and The Palm Tour Service, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to operate as a passenger stage corporation to transport passengers "on-call" for sightseeing tours between hotels/motels in the Cities of Santa Barbara, Goleta, and Montecito, on the one hand, and points of interest in the City and County of Santa Barbara, on the other hand, over and along the routes described, subject to the authority of this Commission to change or modify these routes at any time and subject to the following provisions.

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- b. When route descriptions are given in one direction, they apply to operations in either direction unless otherwise indicated.
- c. Only one-day, on-call, round-trip sightseeing tours shall be conducted, EXCEPT:

Tour #2 - Solvang - shall be restricted to the operation of no more than two tours per week, with no more than one tour operated per weekend.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS. (Continued)

- d. The term "on-call" as used refers to service which is authorized to be rendered dependent on the demands of passengers. The tariffs and timetables of The Pine and The Palm Tour Service shall show the conditions under which each authorized on-call service will be rendered.
- e. All service authorized shall be limited to the transportation of round-trip passengers only.
- f. Applicant shall not pick up or discharge passengers, except at the points and places set forth. This restriction shall not prevent stopovers for the purpose of permitting sightseeing passengers to visit various points of interest along the route.
- g. All tours shall be conducted on a continuous basis except stops necessary for sightseeing, shopping, and/or meals.
- h. Tour stops may be eliminated at the discretion of the individual group. The carrier may make alterations in the tour itinerary within the limits of the authority granted.
