O P I N I O N

By this application, James C. Olsson, consultant for Commercial Transfer, Inc. (Commercial), seeks to amend rules for computation of distances in Pacific Coast Tariff Bureau Tariff No. ICC PCT 409, Cal. P.U.C. No. 30.

Commercial seeks to compute distance by applying a factor of 1.3 to actual miles traveled within Metropolitan Zones rather than applying a flat three-mile assessment. Commercial also seeks to apply factors to the actual mileage when destinations in the Northern Mountain Territory are off the system of maps contained in the Governing Distance Table.

Commercial states that it has found that the assessment of rates under the current rules in the Governing Distance Table are in many cases noncompensatory and the proposal will result in more equitable and reasonable charges.

The application was listed on the Commission's Daily Calendar of September 18, 1981. No objection to the granting of the application has been received.

Findings of Fact

1. The increase and changes resulting from this proposal are justified.
2. The following order has no reasonably foreseeable impact on the energy efficiency of highway carriers.
3. A public hearing is not necessary.

Conclusion of Law

The proposed changes are justified and should be granted.

O R D E R

IT IS ORDERED that:

1. James C. Olsson, consultant for and on behalf of Commercial Transfer, Inc. is authorized to publish in Pacific Coast Tariff Bureau Tariff No. ICC PCT 409, Cal. P.U.C. No. 30 the amendments as specifically proposed in the application.
2. Tariff publications authorized to be made as a result of this order shall be filed not earlier than the effective date of this order and may be made effective not earlier than 5 days after the effective date of this order on not less than 5 days' notice to the Commission and to the public.

3. The authority granted shall expire unless exercised within 90 days after the effective date of this order.

This order becomes effective 30 days from today.
