ORDER OF DISMISSAL

In this complaint, Ponderosa Water Co., Inc. (Ponderosa) seeks an increase in the amount of water purchased from defendant, Pacific Gas and Electric Company (PG&E) in order to have an adequate water supply to serve its customers and to resolve the conflict between Ponderosa and PG&E concerning operations within the same service area.

Resolution W-2884 approved Ponderosa's Advice Letter 26 on September 15, 1981. By that Resolution, Ponderosa was authorized to transfer eight customers now served by PG&E to Ponderosa, to cancel Ponderosa's irrigation schedule, and to establish rates for the transferred customers at the same level as those formerly assessed by PG&E.

Resolution W-2884 stated that Commission authorization will resolve the remaining issues in Case (C.) 10629, in which Ponderosa sought a large water supply from PG&E in order to adequately serve its domestic customers; that Ponderosa and PG&E in C.10629 have agreed that dismissal is appropriate when the actions proposed in

Advice Letter 26 are implemented by a resolution, and that when transfer of the PG&E irrigation customers to Ponderosa is completed, Ponderosa will have a greater water supply by contract with the Federal Bureau of Indian Affairs through the PG&E irrigation canal.

On October 13, 1981, the Commission received a letter jointly signed by representatives of Ponderosa and PG&E, stating as follows:

"Due to the passage of Resolution No. W-2884, dated September 15, 1981, Ponderosa Water Co., Inc., and P.G. & E. request the withdrawal of of Case 10629. The grievances in this case have now been settled. We wish to thank you, the Commission and staff for the help in expediting the resolution."

In the circumstances the requested disposition of C.10629 should be granted.

IT IS ORDERED that Case 10629 is dismissed without

prejudice.
