O P I N I O N

Wayne L. Parker and Dan Duffy (applicants), doing business as Barstow Stage Coach, in Application 60747, have requested a Class B certificate to operate as a charter-party carrier of passengers within a radius of 40 air miles from their home terminal at corner of Highway 58 and Fort Irwin Road, Barstow, CA 92311.

Applicants are the owners of a 44-passenger bus and lease one 44-passenger bus. Applicants show a net worth of approximately \$10,500 as of July 1, 1981.

Notice of the filing of the application appeared in the Commission's Daily Calendar of July 23, 1981, and copies of the application were served upon Greyhound Lines, Inc. and Trailways.

No protests have been received.

Findings of Fact

1. Applicants have the ability, experience, equipment, and financial resources to perform the proposed service.
2. Public convenience and necessity require the service proposed by applicants.
3. Applicants should be authorized to pick up passengers within a radius of 40 air miles from their home terminal at corner of Highway 58 and Fort Irwin Road, Barstow, CA 92311.

4. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

5. A public hearing is not required.

Conclusion of Law

Public convenience and necessity have been demonstrated and a certificate should be granted.

O R D E R

IT IS ORDERED that:

1. A certificate of public convenience and necessity, to be renewed each year, is granted to Wayne L. Parker and Dan Duffy, doing business as Barstow Stage Coach, authorizing them to operate as a Class B charter-party carrier of passengers, as defined in Public Utilities Code Section 5383, from a service area within a radius of 40 air miles from their home terminal at corner of Highway 58 and Fort Irwin Road, Barstow, CA 92311.

2. The Passenger Operations Branch will issue the annual renewable certificate on Form PE-695 as authorized by Resolution PE-303, when it receives California Highway Patrol clearances and evidence of liability protection in compliance with General Order Series 115.


3. In providing service under the certificate, applicants shall comply with General Orders Series 98 and 115, and the California Highway Patrol safety rules.

This order becomes effective 30 days from today.
