Application of Ugalde Trucking Co., Inc., for authority, pursuant to provisions of the Public Utilities Code, to depart from the Minimum rates, rules and regulations of Minimum Rate Tariff No. 7-A.

Application 60787 (Filed August 4, 1981; amended October 8, 1981)

## <u>O P I N I O N</u>

By this application, as amended, Ugalde Trucking Co., Inc. (Ugalde) and 40 carriers who are engaged by Ugalde as underlying carriers seek authority to deviate from certain provisions of Minimum Rate Tariff 7-A (MRT 7-A) in connection with the transportation of earth from the Simi Freeway project located at 118 Freeway between Balboa Blvd. and De Soto Avenue, Granada Hills, California, to various designated dump sites for Poss Constructors, Inc., the subcontractor, who is engaged by Kasler Corporation, the general contractor. The entire project is ultimately paid for by Cal Trans, which is the state agency charged with the responsibility of building and maintaining highways. It is expected the project will extend through July 1, 1982.

Item 130(b) of MRT 7-A provides:

"Upon taking precautions deemed by them to be sufficient to assure payment of charges within the credit period herein specified, carriers may relinquish possession of the freight in advance of payment of the charges thereon and may extend credit in the amount of such charges to debtors for a period not to exceed the 15th day following the last day of the calendar month in which the transportation was performed."

Ugalde seeks authority to deviate from Item 130(b) as

follows:

Carrier may extend credit in the amount of transportation charges incurred by Poss Constructors, Inc. to the 15th day of each calendar month for the transportation performed from the 21st day of the second preceding month to and including the 20th day of the preceding month.

As justification Ugalde states that the request is necessitated in order to conform to the payment practices of Caltrans and the various contractors which are involved. Ugalde alleges that:

> "Caltrans pays the transportation charges to Kasler, the general contractor, on approximately the 10th day of each month. These payments cover only work performed in the two months preceeding the month in which payment is made. The time period covered under this period commences on the 21st day of the first month and ends on the 20th day of the second month. Since Kasler has subcontracted the work to Poss Contractors, Applicant's shipper, the ultimate payment to Applicant is received by the 15th of the month."

Ugalde and the 40 underlying carriers seek authority to deviate from that portion of Item 210 MRT 7-A which provides:

> "The underlying carrier may extend credit to the overlying carrier for a period not to exceed twenty days following the last day of the calendar month in which the transportation was performed, and payment to the underlying carrier must be made within that time. Freight bills for transportation and accessorial charges shall be presented by underlying carriers to overlying carriers within three days after the last calendar day of the month in which the transportation was performed."

Authority is sought by the underlying carriers to extend credit to the 20th day of each month for transportation performed

between the 21st day of the second preceding month to the 20th day of the preceding month. This deviation would coincide with the request of Ugalde in connection with Item 130(b).

The authority will be granted to those 26 underlying carriers who were properly identified in the amendment to the application. The remaining 14 underlying carriers were not properly identified or do not have actual operating authorities.

A copy of the application and the amendment was served upon the California Trucking Association, California Dump Truck Owners Association, Associated Independent Owners Operators, Inc., and California Carriers Association, and was noticed on the Commission's Daily Calendars of August 7 and October 9, 1981, respectively. No timely protests to the granting of the application have been received.

The Commission finds that the request is reasonable and the application should be granted as set forth in the following order. The order which follows should be effective on the date of signature because there is an immediate need for the relief sought.

# O R D E R

IT IS ORDERED that:

 Ugalde Trucking Co., Inc. is authorized to depart from the provisions of MRT 7-A to the extent set forth in Appendix A attached.
The carriers listed in Appendix B are authorized to depart from the provisions of MRT 7-A to the extent set forth in Appendix B attached.

3. The authority granted shall expire September 30, 1982.

Freight bills for transportation and accessorial charges shall be presented by the listed underlying carriers to Ugalde Trucking Co., Inc. no later than the 25th day of each month.

> (E.g., credit may be extended to November 20 and freight bills shall be presented by October 25 for transportation performed from September 21 to October 20.)
