ORDER OF DISMISSAL

An examination of the Commission records disclosed that there were several rate dockets pertaining to highway transportation of property that were still open. Our authority over these matters has been preempted by federal law (PL 103-305).

Notice of our intent to close these dockets by dismissal was published in the Commission's Daily Calendar beginning September 3, 1996, and daily thereafter. In addition, individual copies of this calendar were sent to lariff bureaus, agents, and trucking publications and associations. The calendar notice listed the dockets under consideration for closure by dismissal. It

also gave all concerned until October 1, 1996 to notify Administrative Law Judge (ALJ) Rosenthal of any reason why dismissal should not occur.

As of October 1, 1996, no party to any of these dockets had contacted the ALJ. We shall therefore assume that there is no further purpose in having these dockets remain open.
