# OPINION ON MODIFICATION OF DECISION 96-11-011



SpectraNet Anaheim (applicant), a California corporation, filed its Application 96-05-048 for authority to provide facilities-based and résale local exchange telecommunications service as a competitive local carrier (CLC) and resale interexchange intraLocal Access and Transport Area (intraLATA) services, and interLATA services.

By Decision (D.) 96-11-011, applicant was found to have met all of the requirements necessary to obtain a certificate of public convenience and necessity (CPCN) under Public Utilities Code § 1001 to provide its requested services. However, the Ordering Paragraph granting applicant its CPCN inadvertently excluded authority to provide resale local exchange service. Accordingly, D.96-11-011 should be modified to provide applicant with all of the authority it sought in its application.

## Findings of Fact

1. Applicant sought authority to provide facilities-based and resale local exchange telecommunications service as a CLC and resale interexchange intraLATA and interLATA services.

<sup>1</sup> A competitive local carrier is a common carrier that is issued a CPCN to provide local exchange telecommunications service for a geographic area specified by such carrier.

2. Although D.96-11-011 found that applicant met all of the requirements necessary to obtain a CPCN to provide its requested services, it inadvertently excluded authority to provide resale local exchange services.

## Conclusions of Law

- 1. D.96-11-011 should be modified to allow applicant to provide all of the services it requested authority for.
- 2. Because of the public interest in competitive local exchange services, and interexchange services the following order should be effective immediately.

### ORDER

### IT IS ORDERED that:

- 1. Decision (D.) 96-11-011 shall be modified to provide SpectraNet Anaheim authority to resale local exchange services. Ordering Paragraph 1 of D.96-11-011 shall be modified to read as follows:
  - "1. A certificate of public convenience and necessity is granted to SprectraNet Anaheim (applicant) to operate as a facilities-based and resale competitive local carrier, and resale interexchange interLocal Access and Transport Area (interLATA) and, to the extent authorized by Decision (D.) 94-09-005, intraLocal Access and Transport Area (intraLATA) carrier subject to the terms and conditions set forth below."

Application 96-05-048 is closed.
 This order is effective today.
