OPINION

Summary

Decision (D.) 95-06-022 and D.95-06-023 approved special rate contracts referred to in the above-captioned proceedings, but conditioned approval upon the shareholders rather than ratepayers assuming 100% of the risk of revenue shortfalls resulting from these contracts, unless Pacific Gas and Electric Company (PG&E) demonstrated that some different treatment of such shortfalls was appropriate. (60 CPUC2d, 337, 343.) Application (A.) 95-02-008 and A.95-02-010 were consolidated and held open for the purpose of determining the appropriate treatment of revenue shortfalls, if any, resulting from these special rate contracts.

D.97-08-055 approved as clarified a comprehensive settlement known as the Gas Accord, which considered issues addressed in several applications, including A.95-02-008 and A.95-02-010. PG&E's motion for adoption of the Gas Accord provides that PG&E will assume 100% shareholder responsibility for revenue shortfalls. We determined that there is no ambiguity that PG&E shareholders will bear 100% of the responsibility for revenue shortfalls from transmission rate discounts:

A.95-02-008, A.95-02-010 ALJ/ANG/wav

PG&E's shareholders shall bear all revenue shortfalls from future transmission rate discounts and there is a strong presumption that PG&E's shareholders should bear all revenue shortfalls from future distribution rate discounts, if any. (D.97-08-055, Conclusion of Law 7, mimeo. at p. 65.)

Because D.97-08-055 has disposed of the issues for which A.95-02-008 and A.95-02-010 were held open, these proceedings should now be closed.

Finding of Fact

D.97-08-055 has disposed of the revenue shortfall issues for which A.95-02-008 and A.95-02-010 were held open.

Conclusion of Law

The Commission should close A.95-02-008 and A.95-02-010.
