**ORDER CORRECTING ERROR  
IN DECISION 97-12-084**

This decision corrects a clerical error in Decision (D.) 97-12-084 in which certificates of public convenience and necessity (CPCNs) were issued to a number of facilities-based competitive local carriers (CLCs), including Justice Long Distance Corp. Justice Long Distance filed its request in the form of a separate application, rather than as a petition docketed in I.95-04-044, as prescribed for such filings. In Appendix B to the Decision, we included Justice Long Distance in the group of CLCs being granted CPCNs, but we erroneously identified the application number for Justice Long Distance as Application (A.) 96-08-037. The correct application number is A.97-09-058.

In the Decision, we stated in Ordering Paragraph 25 that "A.97-09-055 and A.96-08-037 are closed". Although A.97-09-055 correctly identified the application filed by Justice Technology Corp., the second application number, A.96-08-037, incorrectly identified the application filed by Justice Long Distance. This decision is therefore issued to correct these erroneous references to the

application filed by Justice Long Distance, and to amend the ordering paragraph to direct that the proper application be closed.

**Findings of Fact**

1. In D.97-12-084, CPCNs were issued to a number of CLCs, including Justice Long Distance.
2. Justice Long Distance filed its request in the form of a separate application, rather than as a petition docketed in I.95-04-044, as prescribed for such filings.
3. The Decision erroneously referred to A.96-08-037, an incorrect application number, in identifying the filing of Justice Long Distance.
4. The correct application number for Justice Long Distance is A.97-09-058.

**Conclusions of Law**


1. D.97-12-084 needs to be modified to reflect the correct application number for Justice Long Distance.
2. The modification to the Decision as noted below should be adopted.

Under Resolution A-4661, IT IS ORDERED that:

1. Ordering Paragraph 25 of Decision (D.) 97-12-084 is hereby modified to read as follows: "A.97-09-055 and A.97-09-058 are closed."
2. Appendix B of D.97-12-084 is modified to substitute "A.97-09-058" instead of "A.96-08-037" in the reference made to the application filed by Justice Long Distance Corp.
