**ORDER CORRECTING ERROR**

Decision (D.) 94-04-003 authorized the transfer of a passenger stage certificate (PSC-1367) from Santa Rosa Airporter, Inc., to E & P Transportation, Inc. The certificate authorizes operations between certain points as specifically set forth in Appendix PSC-9023, attached to the decision. Ordering Paragraph 3 of the decision incorrectly referred to "Appendix PSC-2023." Also, Appendix PSC-9023 omitted Day's Inn as an authorized stop point. These clerical errors heretofore went unnoticed.

Ordering Paragraph 3 of D.94-04-003 should be modified to refer to "Appendix PSC-9023" and revised pages to Appendix PSC-9023 should be issued to include Day's Inn as a stop point. This order is issued under Resolution A-4661.

IT IS ORDERED that Ordering Paragraph 3 of Decision (D.) 94-04-003 is modified to replace "Appendix PSC-2023" with "Appendix PSC-9023" and Appendix PSC-9023 of D.94-04-003, as amended, is further amended by replacing Second Revised Pages 3 and 4 with attached Third Revised Pages 3 and 4.

This order is effective today.
