**ORDER CORRECTING ERRORS IN  
DECISION 98-12-083**

This order corrects certain errors which inadvertently appear in D.98-12-083, regarding the approval of Commission's certificates of public convenience and necessity (CPCN) for competitive local carriers (CLCs) pursuant to Resolution A-4661.

**Summary of Corrections**

The correction of errors relate to Appendix B of the order which sets forth the summary of CLC petitioners and authority granted to each. The errors to be corrected are enumerated below, and the amended version of Appendix B providing the corrected information is appended to this order.

The decision indicated the authority granted to each CLC with an "x" notation in the appropriate column. The decision granted PaeTec Communications, Inc. (PaeTec) only facilities-based authority, but inadvertently omitted CLC resale authority even though PaeTec had requested such resale authority. Accordingly, in the amended Appendix B, PaeTec is granted resale authority.


Advanced Telcom Group, Inc. was erroneously assigned a new U-number in Appendix B even though it had already been assigned a U-number in a prior decision (D.98-11-032 had assigned PaeTec the U-number U-6083-C). The amended Appendix B is corrected to reflect the original U-number assigned to Advanced Telcom Group, Inc.

**IT IS ORDERED that:**

1. Decision (D.) 98-12-083 is amended to incorporate the revised Appendix B attached to this order, which corrects information for PaeTec Communications, Inc. and Advanced TelCom Group, Inc.
2. The revised Appendix B shall supersede the previous version issued as part of Appendix B of D.98-12-083.
