

Decision 99-12-040 December 16, 1999

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Amarjit Singh, Monika Randhawa, and Balbir Singh Ghuman, dba All American A-1 Shuttle Service, for authority to operate as a passenger stage corporation between points in Alameda County, Santa Clara County, San Mateo County, Oakland International, San Francisco International and San Jose International Airports.

O P I N I O N

Summary

This decision grants the application of Amarjit Singh, Monika Randhawa, and Balbir Singh Ghuman (Applicant), a partnership, pursuant to Pub. Util. Code § 1031 et seq., for a certificate of public convenience and necessity to operate as a passenger stage corporation (PSC), as defined in Pub. Util. Code § 226.

Discussion

Applicant requests authority to operate as an on-call PSC to transport passengers and their baggage between certain points in the counties of Alameda, Santa Clara, and San Mateo, on the one hand, and Oakland (OAK), San Francisco (SFO), and San Jose (SJC) International Airports, on the other hand. Applicant will utilize two vans. The proposed fares, as listed in Exhibit C, range between \$12 (Millbrae - SFO) and \$79 (Gilroy - OAK). Attached to the application is the unaudited Balance Sheet as of December 31, 1998, that discloses total assets of \$72,500; total liabilities of \$4,000; and net worth of \$68,500.

Notice of filing of the application, as amended, appeared in the Commission's Daily Calendar on July 20, 1999 and October 6, 1999. Applicant notified the affected airports and cities.

In Resolution ALJ 176-3020 dated July 22, 1999, the Commission preliminarily categorized this application as ratesetting, and preliminarily determined that hearings were not necessary. No protests have been received. Given this status, public hearing is not necessary, and it is not necessary to alter the preliminary determinations made in Resolution ALJ 176-3020.

This is an uncontested matter in which the decision grants the relief requested. Accordingly, pursuant to Pub. Util. Code § 311(g)(2) the otherwise applicable 30-day period for public review and comment is being waived.

Findings of Fact

1. Applicant requests authority to operate as an on-call PSC to transport passengers and their baggage between certain points in the counties of Alameda, Santa Clara, and San Mateo, on the one hand, and OAK, SFO, and SJC, on the other hand.
2. Public convenience and necessity requires the proposed service.
3. No protests to the application have been filed.
4. A public hearing is not necessary.
5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

Conclusions of Law

1. Public convenience and necessity has been demonstrated and the application, as amended, should be granted.
2. Since the matter is uncontested, the decision should be effective on the date it is signed.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

O R D E R

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to the partnership of Amarjit Singh, Monika Randhawa, and Balbir Singh Ghuman (Applicant), authorizing it to operate as a passenger stage corporation, as defined in Pub. Util. Code § 226, to transport persons and their baggage, between the points and over the route set forth in Appendix PSC-12736 subject to the conditions contained in the following paragraphs.

2. Applicant shall:

- a. File a written acceptance of this certificate within 30 days after this order is effective.
- b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
- c. State in the tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
- d. Comply with General Orders Series 101, 104, and 158, and the California Highway Patrol (CHP) safety rules.
- e. Comply with the controlled substance and alcohol testing certification program pursuant to Pub. Util. Code § 1032.1 and General Order Series 158.
- f. Maintain accounting records in conformity with the Uniform System of Accounts.
- g. Remit to the Commission the Transportation Reimbursement Fee required by Pub. Util. Code § 403 when notified by mail to do so.
- h. Comply with Pub. Util. Code §§ 460.7 and 1043, relating to the Workers' Compensation laws of this state.

- i. Enroll all drivers in the pull notice system as required by Section 1808.1 of the Vehicle Code.

3. Applicant is authorized to begin operations on the date that the Rail Safety and Carriers Division mails a notice to Applicant that its evidence of insurance and other documents required by Ordering Paragraph 2 have been filed with the Commission and that the CHP has approved the use of Applicant's vehicles for service.

4. Before beginning service to any airport, Applicant shall notify the airport's governing body. Applicant shall not operate into or on airport property unless such operations are authorized by the airport's governing body.

5. The certificate of public convenience and necessity to operate as a passenger stage corporation (PSC-12736), granted herein, expires, unless exercised within 120 days after the effective date of this order.

6. The Application, as amended, is granted as set forth above.

7. This proceeding is closed.

This order is effective today.
