(IRWIN BROWN, SIDNEY BROWN AND JEFFREY BROWN, INDIVIDUALS,)
(UNDER THE EXCLUSIVE AND PLENARY JURISDICTION OF THE )
(INTERSTATE COMMERCE COMMISSION (ICC).

Taloren, Ltd. (Taloren), a California corporation, doing business as Fleetline Express (T-139,681), holds a highway contract carrier permit and a highway common carrier certificate.

Irwin Brown, Sidney Brown and Jeffrey Brown, individuals, filed a petition with the ICC under 49 U.S.C. 11343(e) for an exemption from the ICC's requirement of prior review and approval of the proposed acquisition of control of Taloren through the purchase of the stock of Taloren. The ICC granted the requested exemption in its decision MC-F-16124, effective July 10, 1985.

We have since been notified by James M. Koshland, counsel for Taloren, that the transaction was consummated on August 13, 1985, and that Irwin Brown is the current president of Taloren.

## Findings of Fact:

- 1. The ICC, having exclusive and plenary jurisdiction, exempted the acquisition of control of Taloren by the above-mentioned individuals from the need for its prior review and approval.
- 2. The control transaction was consummated on August 13, 1985.

## Conclusion of Law:

The Commission concludes that its records should reflect the acquisition of control of Taloren.
