R E S O L U T I O N

SUSPENDING AND REVOKING THE OPERATING AUTHORITY
OF Gloria Fields, doing business as, G. FIELDS
TRUCKING, FOR FAILURE TO COMPLY WITH UNDERCHARGE
CITATION NO. F-3659.

WHEREAS, Gloria Fields, doing business as G. FIELDS TRUCKING, signed an undercharge citation on May 19, 1989 (a copy of which is attached herein); and

WHEREAS, the citation provided that the carrier opted to pay an undercharge fine of \$8,661.02 and not contest the charges set forth in the citation. The carrier further requested and was allowed to make payments of \$1,500 per month. Despite numerous attempts of the staff, both in person and in writing, to obtain compliance, only two payments have been made; and

WHEREAS, the carrier has failed to comply with the requirements of the citation after agreeing to do so in writing;

IT IS RESOLVED THAT:

1. All the operating authority of the above-named carrier is suspended for a period of 30 days, or until the balance of \$5,661.02 is paid. The carrier may not operate during suspension.
2. If by the end of the 30 day period the carrier has not complied with the terms of the citation nor filed for a hearing, then all the operating authority of the above named carrier will be automatically revoked.
3. Filing of a request for hearing will stay the revocation of operating authorities, but the suspension will remain in force. The carrier may not operate.

4. During a hearing, the burden of proof will be on the carrier to show why the revocation should not take place.





and deposited in the mail on or before the date hereinabove specified.

Upon payment of the fine hereinabove specified, it will be deposited in the State Treasury to the credit of the General Fund pursuant to said Section(s) 3800, and the Commission staff will not request the Commission to institute a formal proceeding in this matter provided you proceed diligently to take all reasonable steps including legal action to collect any and all undercharges that may be due from any person or persons as a result of the transportation hereinabove described. If you should fail to take such steps, the Commission may institute a formal investigation on its own motion to inquire into the circumstances of such failure.

Failure to answer this citation in either of the ways hereinabove described or to collect the undercharges may itself be considered by the Commission in a formal proceeding commenced on its own motion as a distinct violation of law, and may itself be cause for canceling, revoking, or suspending your operating authority, or imposing upon you a fine pursuant to Section(s) 3774 of the Public Utilities Code.
