RESOLUTION SUSPENDING AND REVOKING THE OPERATING AUTHORITY OF BERNARD T. CARBY, DOING BUSINESS AS CARBY & SONS TRUCKING FOR FAILURE TO COMPLY WITH CITATION FORFBITURE NO. F-3003

WHEREAS: On May 15, 1986, Bernard T. Carey, dba Carey & Sons Trucking was served with Citation Forfeiture No. F-3003 (a copy of which is attached); and

WHEREAS: The carrier agreed in writing to not contest the citation and to pay the fine of \$750 in seven monthly installments, commencing July 2, 1986; and

WHEREAS: The carrier has failed to make any payments toward the fine;

THEREFORE: IT IS ORDERED that:

- 1) The highway contract carrier permit of the above-named carrier is suspended for a period of 30 days, or until the citation fine of \$750 is paid in full:
- 2) If by the end of the 30-day period the carrier has not paid the fine nor filed for a hearing, then the carrier's permit will be automatically revoked.
- 3) Filing of a request for hearing will stay the revocation of the permit, but the suspension will remain in force. The carrier may not operate.
- 4) During a hearing, the burden of proof will be on the carrier to show why the revocation should not take place.

The Executive Director is directed to mail a certified copy of this resolution to Bernard T. Carey, dba Carey & Sons Trucking.

This resolution is effective today.
