RESOLUTION

(RESOLUTION SUSPENDING AND REVOKING THE OPERATING
(AUTHORITY OF PATRICK EDWARD MOORE, DBA
(P M TRANSPORTATION FOR FAILURE TO COMPLY WITH
(CITATION FORFEITURE NO. F-4398.

WHEREAS: On October 1, 1991, Partick Edward Moore, dba P M Transportation (P M), was served with Citation Forfeiture No. F-4398, and signed the citation (copy attached); and

WHEREAS: The carrier agreed in writing to not contest the citation and to pay the fine of \$1,000 imposed by Citation Forfeiture No. 4398 in five monthly installments of \$200 each, on the 15th of the month, beginning with November. Carrier was mailed a Fine Payment Agreement to be returned with his first payment. By December 18th no communication nor payment was received and staff sent a letter requesting payment by January 6, 1992; and

WHEREAS: On January 10, 1992, a warning letter and copy of Resolution L-228, which sets forth Commission procedure for suspending and revoking operating authority for noncompliance, was sent to P M; and

WHEREAS: On January 22nd carrier sent a letter requesting a lower payment of \$100 per month, to which staff agreed. Carrier set February 20th as the due date for its first payment; and

WHEREAS: On March 17, 1992 a payment of \$200 was received, but since then there has been no further communication;

THEREFORE, It is Ordered that:

- The Highway Contract Carrier Permit of the above-named carrier be suspended for a period of 30 days, or until the \$800 balance of the citation forfeiture fine is paid in full.
- 2) If by the end of the 30-day period the carrier has not paid the fine nor filed for a hearing, then the carrier's operating authority will be automatically revoked.

- 3) Filing of a request for hearing will stay the revocation of the permits, but the suspension will remain in force. The carrier may not operate.
- 4) During a hearing, the burden of proof will be on the carrier to show why the revocation should not take place.

The Executive Director is directed to mail a certified copy of this Resolution to Patrick E. Moore, dba P M Transportation.

This Resolution is effective today.
