### RESOLUTION

( RESOLUTION SUSPENDING AND REVOKING THE OPERATING )
( AUTHORITY OF RAMI NJIB AYOUB, DBA PARK LANE LIMOUSINE)
( FOR FAILURE TO COMPLY WITH )
( CITATION FORFEITURE NO. F-4381 )

WHEREAS: On October 31, 1991, Park Lane Limousine was served with Citation Forfeiture No. F-4381 (copy attached); and

WHEREAS: The carrier agreed in writing to not contest the citation and to pay the fine of \$750 imposed by Citation Forfeiture No. 4381 in five installments of \$150; the first payment was to accompany the signed installment payment agreement and the four remaining to be remitted each month on the 6th day; and

WHEREAS: The carrier has made two payments, one on December 12, 1991 and the next on March 2, 1992, and since the last payment carrier has not contacted the Commission nor responded to the two letters sent requesting payment and warning carrier of the consequences of non-payment;

#### THEREFORE, IT IS ORDERED that:

- 1) The Charter Party Carrier Permit of the above-named carrier is suspended for a period of 30 days, or until the balance of the citation forfeiture fine is paid in full.
- 2) If by the end of the 30-day period the carrier has not paid the fine nor filed for a hearing, then the carrier's operating authority will be automatically revoked.
- 3) Filing of a request for hearing will stay the revocation of the permit, but the suspension will remain in force. The carrier may not operate.
- 4) During a hearing, the burden of proof will be on the carrier to show cause why the revocation should not take place.


