## R E S O L U T I O N

( SUSPENDING AND REVOKING THE OPERATING AUTHORITY OF )  
 ( PAMELA SHERMAN, DOING BUSINESS AS SHERMAN TRUCKING, )  
 ( FOR FAILURE TO COMPLY WITH THE TERMS OF )  
 ( CITATION FORFEITURE NO. F-4525. )

WHEREAS, on October 3, 1984, the Commission approved Resolution No. L-228, adopting a policy for carriers who have operating authority issued by the Commission and who fail to comply with citations issued by the Transportation Division, which policy allows the Executive Director to recommend suspension and revocation of that authority for such failure to comply; and

WHEREAS, on June 25, 1992, the Transportation Division served the carrier with Citation Forfeiture No. F-4525 in the amount of \$5,000.00 which payment was due July 10, 1992; and

WHEREAS, the carrier requested and received the opportunity to pay the \$5,000.00 obligation in installments of \$1,000.00 per month commencing July 15, 1992 but has not complied with the terms of its payment plan and, to date, has not submitted a single payment; and

WHEREAS, on August 26, 1992, the Transportation Division advised the carrier that its operating authority is subject to suspension and revocation for failure to comply with the citation pursuant to Resolution No. L-228; and

WHEREAS, on September 30, 1992, the Transportation Division notified the carrier that no payment had been received and warning it that failure to pay the delinquent fine by October 15, 1992, the staff will take steps to suspend and revoke its operating authority; and

WHEREAS, to date, no payment has been received; and

WHEREAS, the carrier's failure to comply with the citation forfeiture continues;

## IT IS RESOLVED THAT:

1. Sherman Trucking Inc. is hereby directed to remit the \$5,000.00 in three monthly installments of \$1,666.67. Each installment is due on the fifteenth day of each successive month as follows: December 15, 1992, January 15, 1993 and February 15, 1993.

2. In the event that any one of the three payments is not received within ten days of the date due, the operating authority is suspended as of that date; if such delinquent installment is not received within the following ten days, the operating authority is revoked.

3. At any time prior to the complete payment of the \$5,000.00 balance, the carrier may request a hearing on this matter.

4. During the hearing, the carrier will have the burden of showing cause why its authority should not be revoked.

5. This resolution expires with the full receipt of the \$5,000.00 balance due or upon the revocation of the operating authority.


