(RESOLUTION SUSPENDING AND REVOKING THE HOUSEHOLD GOODS)
(CARRIER PERMIT OF GRETCHEN UNREIN, AN INDIVIDUAL DOING)
(BUSINESS AS ONE STOP MOVING CENTER FOR FAILURE TO PRODUCE)
(RECORDS FOR EXAMINATION.)

Gretchen Unrein, an individual doing business as One Stop Moving Center (T-147602), 405 W. Washington Street., #126, San Diego, CA 92103 holds a household goods carrier permit issued by this Commission.

By telephone on March 1, and 8, 1988 and letter dated August 15, 1988 pursuant to Sections 5221 and 5225 of the Public Utilities Code, this carrier was informed that the Commission's Transportation Division desired to examine her transportation records for the purpose of determining compliance with the Commission's rules and regulations. The carrier was requested to produce certain specified records covering the period January 1, 1988 to June 30, 1988, inclusive, at the Commission's Office at 1350 Front Street, Room 4006 San Diego on August 25, 1988 at 8:30 a.m.

The carrier did not produce her records in response to the staff's requests. Several prior attempts to examine this carrier's records were also disregarded. The carrier has made no subsequent attempt to comply with the staff's request to furnish her records for examination.

The Commission finds that Gretchen Unrein, doing business as one Stop Moving Center has failed to produce the records pertaining to her operations as a Household Goods Carrier after sufficient requests have been made upon her pursuant to Sections 5221 and 5225 of the Public Utilities Code. The Commission concludes that her Household Goods Carrier Permit should be suspended and revoked unless the records are produced for examination.

IT IS ORDERED that:

The Household Goods Carrier Permit issued to Gretchen Unrein, doing business as One Stop Moving Center, is suspended thirty days after the effective date of this order and should be revoked thirty days after the date of suspension, unless prior to the dates of suspension and revocation the carrier produces the records specified below for examination in the Commission's office located at 1350 Front Street, Room 4006 San Diego, CA 92101 (telephone (619) 237-7388) at a mutually agreed upon time.

The carrier shall produce all accounts, books, records, memoranda, documents, papers, correspondence, and any other supporting documents covering the period January 1, 1988 to June 30, 1988, inclusive.

Should Gretchen Unrein desire to protest this action, a formal application requesting a hearing must be filed in accordance with the Commission's Rules of Practice and Procedure. Such application will stay the revocation of carrier's operating authority.

The Executive Director is directed to cause service of a certified copy of this resolution on Gretchen Unrein.

The effective date of this order is the date of service upon the carrier.
