RESOLUTION

SUSPENDING AND REVOKING THE OPERATING AUTHORITY OF RAFAEL RODAS, DOING BUSINESS AS CALIFORNIA SOIL SERVICES, FOR FAILURE TO COMPLY WITH THE TERMS OF A CITATION.

C

WHEREAS, on October 3, 1984, the Commission approved Resolution No. L-228, adopting a policy for carriers who have operating authorities issued by the Commission and who fail to comply with a citation forfeiture issued by the Safety and Enforcement Division, a policy that allows the Executive Director to recommend suspension and revocation of the authorities for such failure to comply;

WHEREAS, Rafael Rodas, doing business as California Soil Services, holds a Dump Truck Carrier permit issued by the Commission on January 7, 1994;

WHEREAS, on March 22, 1995, the Transportation Division, predecessor to the Safety and Enforcement Division, served Rafael Rodas (Rodas) with Citation Forfeiture No. F-4909 for \$1,500 which Rodas agreed to pay;

WHEREAS, on April 6, 1995, Rodas proposed to pay the \$1,500 obligation by promising to make \$200 monthly payment commencing May 20, 1995, until the total amount is paid in full, to which proposal the staff agreed;

WHEREAS, on May 10, 1995, the staff sent Rodas a Fine Payment Agreement to sign and return;

WHEREAS, on June 13, 1995, the staff reminded Rodas that the signed Fine Payment Agreement had not been received and warned him of the consequence of failing to comply with the terms of the citation; Resolution No. CE 9-95 November 21, 1995 Page 2

WHEREAS, on July 3, 1995, the staff notified Rodas by letter to call immediately regarding the above citation, but no response was received;

WHEREAS, on August 6, 1995, the staff notified Rodas that he was three payments delinquent for a total of \$600, and warned him that it would take steps to suspend and revoke his operating authority;

WHEREAS, on September 15, 1995, Rodas was notified that staff had begun the process of suspending and revoking his operating authority;

WHEREAS, to date, staff has not received any response from Rodas, nor has he made any payments, thereby ignoring all staff's attempts to communicate with him and breaking his promise of April 6;

WHEREAS, the Safety and Enforcement Division has properly advised Rodas of the consequences of his failure to comply with the citation, pursuant to the provisions of Resolution No. L-228; and;

WHEREAS, Rodas' failure to comply with the citation continues;

IT IS RESOLVED THAT:

1. The operating authority of Rafael Rodas, doing business as California Soil Services, is suspended for a period of 30 days, or until the delinquent amount of the citation is paid, during which time Rodas may not operate.

2. If by the end of the 30-day period, Rodas has neither complied with the terms of the citation nor requested a hearing, the operating authority will be automatically revoked.

3. Although a request for a hearing will stay the revocation of the operating authority, absent full payment of the delinquent amount of the citation and compliance with all other Commission rules and regulations, the suspension will remain in force and Rodas may not operate.

4. During the hearing, Rodas will have the burden of showing cause why the operating authority should not be revoked.
