**RESOLUTION AUTHORIZING DESIGNATED EMPLOYEES IN THE CONSUMER SERVICES DIVISION TO EXERCISE POWERS OF PEACE OFFICERS WITHIN THE SCOPE OF THEIR DUTIES AS SPECIFIED IN PENAL CODE SECTION 830.11 AND PUBLIC UTILITIES CODE SECTION 308.5 AND APPOINTING THOSE EMPLOYEES AS PERSONS WHO MAY PERFORM SPECIFIC DUTIES DESCRIBED BY PUBLIC UTILITIES CODE SECTION 308.**

Stephanie Amato, Dao Phan, and Duane Filer, Special Agents, assigned to the Utility Enforcement Branch, Consumer Services Division, have successfully completed their mandatory training, pursuant to Penal Code Section 832, at the Criminal Justice Training Center, Evergreen Valley College, San Jose and Rio Hondo College, Whittier.

The above named employees of the Consumer Services Division have been designated, pursuant to Penal Code Section 830.11(a)(5) by Director William R. Schulte, as persons having powers of peace officers.

**THEREFORE, IT IS ORDERED that:**


1. Pursuant to Penal Code Section 830.11(a)(5), the above-named employees of the Consumer Services Division (successor to the Safety and Enforcement Division) are hereby approved and authorized to exercise the powers of arrest as specified in Penal Code Section 836, and the power to serve warrants as specified in Penal Code Section 1523 and 1530 during the course and within the scope of their employment, as provided by Penal Code Section 830.11(a)(5) and Public Utilities Code Section 308.5.
2. Each of these employees of the Consumer Services Division is further hereby designated as an "authorized official" within the meaning of Public Utilities Code 5322(j).
3. These employees are further hereby appointed as persons who may serve Commission related warrants and other process pursuant to Public Utilities Code Section 308.
