## RESQLUTIÓN

RESOLUTION E-3142, SOUTHERN CALIFORNIA EDISON COMPANY (EDISON) AUTHORIZATION TO REVISE SPECIAL CONDITION NO. 5 OF SCHEDULE NO. RTP-2, REAL TIME PRICING TEST, REGARDING VOLTAGE DISCOUNTS.

BY ADVICE LETTER 821-B, FILED PEBRUARY 10, 1989.

#### SUMMARY

1. By Advice Letter 821-E filed February 10, 1989, Southern California Edison Company (Edison) requests Commission approval to revise its Schedule No. RTP-2, Special Condition No. 5, Voltage Discounts, Real Time Pricing Test, in order to preserve revenue neutrality between Schedule No. RTP-2 and Schedule No. TOU-8 rates for customers served at these voltages.

2. This Resolution authorizes the request.

#### BACKGROUND

1. Edison requests authorization to revise rate Schedule No. RTP-2. The revisions are intended to make this schedule revenue neutral relative to the alternate schedule TOU-8 and thus be consistent with the revisions to Schedule No. RTP approved by the Commission in Resolution No. E-3111, dated October 26, 1988, and the tariff restructuring in Edison's General Rate Case Decision No. (D.) 87-12-066, dated December 22, 1987. The changes requested herein should also have been made at that time but they were overlooked.

# DISCUSSION

1. To preserve revenue neutrality between Schedule No. RTP-2 rates and Schedule No. TOU-8 rates for customers served at certain these voltages, Special Condition No. 5, Voltage Discounts, on Schedule No. RTP-2 is modified by changing the Voltage Discount percentages from 2.0% to 4.5%, for customers with service delivered and metered at voltages from 2 kV through 50 kV, and from 5.8% to 15.4% for customers with service delivered and metered at voltages above 50 kV. The Voltage Discount is designed to be revenue neutral relative to the discount the customer would have received had the customer remained on Schedule No. TOU-8.

2. The Commission Advisory and Compliance Division (CACD) has reviewed this filing and cost support workpaper provided by Edison and determined that it is reasonable to revise Special Condition No. 5, Voltage Discounts, on Schedule No. RTP-2 in order to preserve revenue neutrality between Schedule No. RTP-2 rate and Schedule No. TOU-8 rate. The cost data prepared by Edison is the same as that which the Commission relied upon in D. 87-12-066.

3. Except as noted above, this filing will not increase any rate or charge, cause the withdrawal of service, nor conflict with any schedules or rules.

4. Public notification has been made by supplying copies of this filing to other utilities and parties requesting notification of advice filings.

#### PROTESTS

1. No protests to this advice letter have been received by CACD.

### FINDINGS

1. Edison's request to modify Special Condition No. 5, Voltage Discounts, on Schedule No. RTP-2, as discussed above, is reasonable.

2. The revision makes Schedule No. RTP-2 consistent with the tariff restructuring in Edison's General rate Case D. 87-12-066.
