R E S O L U T I O N

GRANTING AN EXEMPTION FROM GENERAL ORDER 72-B TO PERMIT THE INSTALLATION OF RUBBER GRADE CROSSING SURFACES AT THIRTEEN CROSSINGS OF THE SOUTHERN PACIFIC TRANSPORTATION COMPANY'S TRACKS AND FORTY-SIX CROSSINGS OF THE LOS ANGELES COUNTY TRANSPORTATION COMMISSION'S TRACKS IN THE CITIES OF LOS ANGELES, LONG BEACH, AND COMPTON, AND UNINCORPORATED AREAS, LOS ANGELES COUNTY.

The Los Angeles County Transportation Commission (LACTC), by letter dated May 11, 1988, has requested that it and the Southern Pacific Transportation Company (SPT) be granted an exemption from General Order 72-B to permit the installation of rubber grade surfaces at forty six of LACTC's crossings and thirteen of SPT's crossings listed below in the Cities of Los Angeles, Long Beach, and Compton, and unincorporated areas, in Los Angeles County:


