Order instituting investigation of SIERRA PACIFIC POWER COMPANY éléctric ratés and chargés for éléctric sérvicé.

ORDER INSTITUTING INVESTIGATION UNUCIUM

On August 15, 1989, Siérra Pacific Power Company (SPPC) filed Application (A.) 89-08-027 requesting authority to incréase base rate révénués for éléctricity by \$1.539 million for test year 1990.

Without prejudging the issues which may arise in A.89-08-027, we institute this investigation so we have a procedural forum and vehicle to fully act on recommendations on revenue requirement, rates, practices and other aspects of SPPC's operations which may be beyond the confines of the relief requested in A.89-08-027. The opening of such investigatory proceedings, for consolidation with utilities' general rate applications, is customary. It is appropriate, in order to fully use the extensive general rate case review, to have such consolidated proceedings. The evidentiary record developed in A.89-08-027 and this consolidated OII, taken together, shall be the common record to support any findings or orders in connection with this investigation.

Accordingly, and on authority of Public Utilities Code Section 729, we will institute an investigation into the rates, charges and practices of Sierra Pacific Power Company. This investigation will be consolidated with A.89-08-027 for hearing and decision.

Therefore, IT IS HEREBY ORDERED that:

1. Pursuant to Public Utilities Code Section 729, an investigation into the rates, charges and practices of the Sierra Pacific Power Company is hereby instituted.

2. This invéstigation is consolidated with A.89-08-027 and the record in that proceeding will form the basis of the Commission's investigation.

3. A public héaring in this matter shall bé héld béforé an Administrativé Law Judgé of thé Commission at a timé and placé to bé détérminéd, at which timé and placé all intéréstéd parties may appéar and bé héard.

4. The Executive Director is directed to cause a certified copy of this order to be served by certified mail on SPPC and to cause a certified copy of this order to be served by mail on each party of record in the SPPC's general rate case, A.89-08-027.
