ORDER INSTITUTING INVESTIGATION

Ronald D. Gray, (Respondent Carrier and/or Gray) an individual whose mailing address is 7855 Berry Road, Bakersfield, CA 93307, is engaged in the business of transporting property over the public highways of this state for compensation. Gray operates pursuant to a dump truck carrier permit issued July 10, 1978 (T-123,711).

The following respondents, hereinafter referred to as "respondent shippers", have received services from respondent Gray in the form of transportation of property over the public highways of this state for compensation, and as such are shippers of property:

It appears that respondent Gray may have provided, by means of a device or otherwise, the respondent shippers with transportation services over the public highways of this state

for compensation at rates less than the minimum rates established by the Commission in Minimum Rate Tariff 7-A.

It further appears, after review of relevant documents and records, that the above named carrier may have violated Sections 3664, 3667, 3668 and 3737 of the Public Utilities Code.

It further appears that respondents Davis Earthmoving Company, Inc. (Davis) and J. L. Denio, Inc. (Denio) may have knowingly and willfully procured, by means of a device or otherwise, from respondent Ronald D. Gray, transportation services over the public highways of this state for compensation at rates less than the minimum rates established by the Commission in Minimum Rate Tariff 7-A.

Good cause appearing; therefore,

**IT IS ORDERED** that an investigation on the Commission's own motion is hereby instituted into the operations, rates, charges and practices of respondent Gray and the shipper respondents for the purpose of determining:

1. Whether respondent Gray in transporting base rock for the respondent shippers, violated Sections 3664, 3667, 3668 and 3737 of the Public Utilities Code by failing to assess and collect the applicable minimum rates as set forth in Minimum Rate Tariff 7-A.

2. Whether respondent shippers, or persons liable therefor, have paid less than the applicable rates and charges for transportation performed by respondent carrier. Respondent shippers participated in and were paid based upon the devices of a fraudulent rate conversion, a buy and sell arrangement, and an alter ego carrier shipper affiliation.

3. Whether respondent Davis Earthmoving Company, Inc. (Davis), knowingly and wilfully, by means of a device or otherwise, violated Section 3669 of the Public Utilities Code, by procuring from respondent Gray transportation service at rates less than the applicable minimum rates established by the Commission in that respondent Davis has been assessed reduced rates based upon a fraudulent buy and sell arrangement, false documentation and the device of a rate conversion in which

respondent carrier Gray converted the tonnage rates to hourly rates which were less than the applicable minimum rates and charges established by the Commission.

4. Whether a fine should be imposed upon respondent shipper Davis pursuant to Sections 3804.1 and 3805 of the Public Utilities Code.

5. Whether respondent J. L. Denio, Inc. (Denio), knowingly and wilfully, by means of a device or otherwise, violated Section 3669 of the Public Utilities Code, by procuring from respondent Gray transportation service at rates less than the applicable minimum rates established by the Commission in that respondent Denio, an affiliated carrier shipper which holds operating authority from this Commission, violated the restriction on its Dump Truck Carrier Permit by engaging respondent carrier Gray for the transportation of property of J. L. Denio, Inc. and paid the carrier less than 100% of the applicable minimum rates and charges established by the Commission.

6. Whether respondent J. L. Denio, Inc. knowingly and wilfully, by means of a device or otherwise, violated Section 3669 of the Public Utilities Code, by procuring from respondent Gray service at rates less than the applicable minimum rates established by the Commission in that respondent Denio has been charged reduced rates based upon a fraudulent buy and sell arrangement, false documentation and the device of a rate conversion in which respondent carrier Gray converted the tonnage rates to hourly rates which were less than the applicable minimum rates and charges established by the Commission.

7. Whether a fine should be imposed upon respondent shipper Denio pursuant to Section 3804.1 and 3805 of the Public Utilities Code.

8. Whether, in the event respondent Gray is found to have failed to assess and collect said applicable minimum rates through the devices of a buy and sell arrangement, false documentation, rate conversion and transportation performed for a carrier affiliated shipper, or otherwise, a fine in the amount of

the undercharges should be imposed upon respondent Gray pursuant to Section 3800 of the Public Utilities Code.

9. Whether the respondent carrier should be ordered to collect from the aforementioned respondent shippers the difference between the charges actually received and the applicable rates and charges pursuant to Section 3800 of the Public Utilities Code.

10. Whether, any or all of respondent carriers' operating authority should be cancelled, revoked, or suspended, or in the alternative, a fine of up to \$20,000 for each offense be imposed pursuant to Sections 3774 and 3805 of the Public Utilities Code.

11. Whether respondents Gray, Davis and Denio should be ordered to cease and desist from any and all unlawful operations and practices.

12. The scope of the investigation includes, but is not limited to transportation represented by the invoices listed in Attachment A and B, appended hereto.

13. Whether any other orders that may be appropriate should be entered in the lawful exercise of the Commission's jurisdiction.

A public hearing in this matter shall be held before an Administrative Law Judge of the Commission at a time and place to be determined, at which time and place all interested parties may appear and be heard.

The Executive Director is directed to cause a certified copy of this order to be served by mail on all respondents, Davis Earthmoving Company, Inc., J. L. Denio, Inc. and Ronald D. Gray.


