ORDER INSTITUTING INVESTIGATION

This Order Instituting Investigation (OII) is issued to address a possible change in the way the State Board of Equalization ("Board") assesses property owned by California's regulated telephone, gas, electric, and multi-county water utilities. The Commission Staff has been informed that the Board and many of these utilities are likely to enter into a settlement of utility claims that the Board is overassessing utility property. It appears that the settlement will result in lower assessments over the course of the next eight years and substantially reduce annual property taxes of the major stationary utilities.

BACKGROUND

The Union Pacific Railroad Company and AT&T Corporation filed cases in the California courts alleging that the Board had overassessed their utility property. In Union Pacific Railroad Company et al. v. State Board of Equalization, (San Francisco County Superior Court Nos. 761819, 778986, 788219), the Board was ordered to refund taxes to the three railroad plaintiffs. On June 27, 1991, this decision was affirmed on appeal, although the appellate court found that the trial court erred in finding illegal certain Board techniques for estimating railroad income. (231 Cal. App. 3d 983.)

On February 4, 1991, AT&T Communications of California also obtained a favorable trial court decision ordering refunds plus accrued interest at the rate of 9%. (AT&T Communications of California, and American Telephone and Telegraph Company vs. State Board of Equalization (Sacramento County Superior Court, Nos. 500802 and 500803).) The AT&T decision is currently being appealed by the Board. Pacific Bell filed suit in April, 1990, and Pacific Gas and Electric (PG&E) in June, 1991. GTE and Continental Telephone Company have also filed suits.

After a number of counties pointed out how adversely they might be impacted by the tax refunds the utilities might obtain, and after the Board expressed interest in negotiating a settlement, PG&E withdrew its lawsuit in favor of settlement negotiations. In light of the court rulings, the counties, the Board, and a number of utilities are negotiating a settlement regarding future assessment of utility property. The settlement may well result in substantial reductions in utility property tax payments.

SCOPE OF PROCEEDING

We intend to ensure that ratepayers receive the full benefits of property tax reductions resulting from any settlement. This OII will determine the best way to flow all such tax reductions through to customers of affected utilities as expeditiously as possible.

We will order utility rates collected hereafter subject to refund for the purpose of flowing through to ratepayers the tax savings available under the settlement or resulting from any similar changes in assessment methods. We will also order the utility respondents to establish property tax overcollection memorandum accounts.

The Commission will assign an Administrative Law Judge (ALJ) to this proceeding. Once a settlement has been approved by the settling parties, the ALJ will issue a ruling setting forth further procedures to be followed in this investigation. We

envison that these procedures will include: (A) the submission of proposals for utility tariff filings to flow through to ratepayers any property tax reductions; and (B) submission by each utility of its best estimate of the effect of the settlement, including a comparison of the assessed valuation of its property under the terms of the settlement to the valuation under the previous method of assessment, and specifically identifying the dollar change in its property taxes for at least the first three years of the agreement.

We deem the reasonableness of the terms of the settlement between the utilities and the Board to be non-justiciable in this or subsequent Commission proceedings. In deferring to the Board we do not enunciate a policy of non-justiciability with respect to settlements concluded between utilities and entities other than the State of California. Our policy is restricted to and predicated upon recognition that the Board of Equalization is the branch of California's government with primary jurisdiction and responsibility to assess utility-owned property, while this Commission has no special competence or expertise in the area of property taxation.

We wish to stress that our enunciation of a policy declining to exercise jurisdiction and refusing to second-guess the expert judgment of a sister state agency involves no retreat from our holding in Apple Valley Ranchos Water Company, 25 Cal. P.U.C. 2d 140, 158 (1987). In Apple Valley, we forcefully asserted that regardless of the errors or strategic mistakes made by a utility in computing its tax liability, the Commission will impute as a reasonable cost of doing business a tax return which took every legitimate step toward tax minimization. Such a position is in full accord with the views of the Supreme Court as expressed in City and County of San Francisco v. Public Utilities Commission, 6 Cal. 3d 119, 127 (1971). The instant settlement is clearly distinguishable from the fact patterns reviewed in Apple Valley and City and County of San Francisco. There we were faced with situations in which the utilities had failed to take

advantage of deductions allowable under existing tax law. It is one thing for the Commission to insist upon a policy of holding a utility to every method permitted by the terms of tax codes to minimize its liabilities. That is to make aggressive use of the law. It is a quantum extension of that policy to suggest that a utility has an obligation to challenge the law under which taxes are collected or the administration of that law by the tax assessing agency.

While the reasonableness of the terms of the settlement has been declared non-justiciable, their implementation by the utilities is an issue falling squarely within the Apple Valley and City and County of San Francisco precedents. Thus, we will insist that the utilities take full advantage of the opportunities presented by the settlement to lower their property tax payments.

CONCLUSION OF LAW

This Commission declines to exercise its jurisdiction to review the reasonableness of the terms of the settlement between the utilities and the Board of Equalization. We deem the reasonableness of the terms of the settlement to be non-justiciable in this or subsequent Commission proceedings. We thus defer to our sister state agency because the Board is the branch of California's government with primary jurisdiction and responsibility to assess utility-owned property, while this Commission has no special competence or expertise in the area of property taxation.

ORDER

IT IS ORDERED that:

1. An investigation on the Commission's own motion is hereby instituted to determine what methodology the Commission should use to flow through to ratepayers the tax savings

available under the settlement or resulting from any similar changes in assessment methods.

2. The utilities listed in Appendix A are named respondents to this proceeding.

3. Rates hereafter collected by each and every respondent shall be collected subject to refund for the purpose of flowing through to ratepayers the tax savings available under the settlement or resulting from any similar changes in assessment methods.

4. Each and every respondent shall establish a property tax overcollection memorandum account and record in it the decrease in its revenue requirement that would be necessary to fully reflect any decrease in property taxes available under the settlement or resulting from any similar changes in assessment methods. These accounts shall accrue interest at the average three month commercial paper rate as published in the Federal Reserve Bulletin until such time as the decreased property taxes are reflected in the respective utility's revenue requirements.


5. The Executive Director shall mail a copy of this order to all parties listed in Appendices A and B.
