The common carrier tariffs, common carrier contracts and special contracts listed below violate Commission Decision (0.) 90-02-021 and have been suspended. These rate filings have not been amended or corrected and will go into effect at the end of the suspension period, unless the Commission orders these rate filings to be cancelled.
