RESOLUTION NO. OCR-1024 ORDER CANCELLING COMMON CARRIER TARIFFS, COMMON CARRIER CONTRACTS, AND SPECIAL CONTRACTS WHICH HAVE BEEN TEMPORARILY SUSPENDED FOR VIOLATION OF D.90-02-021.

OCR 1 Crown Transport Systems, Inc. The tariff filing contains a shipper-specific provision which is prohibited by Commission Decision 90-02-021.

OCR 2 <u>RIP Trucking</u> Carrier files an increase in rates but fails to observe the applicable rules in General Order 147-B.

OCR 3 <u>Public Freight Service, Inc.</u> Carrier fails to identify geographic locations for mileage computation, and carrier's contract authority was revoked.

OCR 4 Best Delivery Service, Inc. Special Contract T-114,751-398 does not contain the shipper's signature as required by Rule 6.6(b) of General Order 147-B.

These rate filings have not been amended or corrected and will go into effect at the end of the suspension period, unless the Commission orders these rate filings to be cancelled.

Item 3001, which shows "Account #83542," represents a writein type rate. The Commission found this method of publishing tariff to be discriminatory in Decision 90-02-021 and ordered its elimination from all common carrier tariffs within 120 days from March 15, 1990.

In conformity with the findings and order made by the Commission in a resolution entered this day, RIP Trucking is ordered to cancel <u>Item 300 (1st Revised Page 23)</u> of Local Freight Tariff 1 by June 2, 1991.

Item 300 provides for a fee of 1.5% of the unpaid balance per month to compensate for administrative costs. Imposition of fee for late payment will result in a rate increase. Rate increase greater than 10% of the carrier's base rate requires formal application and rate increase within the zone of reasonableness must cite on the rate page the tariff page, item number, and the effective date of the base rate. Neither rule was observed by the carrier.

Your special contract with 3M refers to a Zip Zone Distance Table and a Zip Code Distance Chart but there is nothing to show how to identify geographic points for mileage computation. In addition, your operating authority was revoked February 28, 1991.

This contract was suspended on May 3, 1991, for 30 days because the governing distance guide was not filed with the contract, and the operating authority of the carrier had not been reinstated at the time of the filing.
