In conformity with the findings and order made by the Commission in a resolution entered this day, Special Contract T-127,109-05 with Compass Lumber Company is ordered canceled and will not go into effect July 5, 1991.

The contract with Compass Lumber Company does not meet the criteria set forth in Rule 3.18 of General Order 147-B to establish a special contract. There is no indication of substantial shipper obligations, nor any service not normally provided under common carrier tariff rates or a minimum monthly revenue of \$1000 to be achieved. In addition, ambiguities exist in the contract frustrating any attempt to accurately determine the applicable rates to be assessed on a shipment in violation of Rule 6.6 (f) of General Order 147-B.

The contract was listed on the Commission's Daily Transportation Calendar on May 29, 1991 and was suspended for 30 days effective June 4, 1991.
