In conformity with the findings and order made by the Commission in a resolution entered this day, Special Contract T-164,571-101 is ordered canceled and will not go into effect January 18, 1992.

Special contracts must include evidence of substantial shipper obligation in the contract. To meet this requirement the contract must either provide for the carrier to earn a minimum of \$1,000 per month for delivered transportation services, or the contract must call for substantial shipper obligations not normally provided under common carrier tariff rates by any carrier. Ralph I. Miller Trucking filed special contract number T-164,571-101 with Reid & Wright, Inc., which appeared on the Commission's Daily Transportation Calendar December 18, 1991. The contract was suspended on December 19, 1991 for 30 days because it did not include evidence of the substantial shipper obligation, required by Rule 6.14 of General Order 147-C. In addition, the contract lacks the specific effective date as required by Rule 8.2 of General Order 147-C.
