
Conclusion of Law



In conformity with the findings and order made by the Commission in a resolution entered this day, Contracts T-172,716-1 through 394 are ordered canceled and will not go into effect.

Special contracts must include evidence of substantial shipper obligation in the contract. To meet this requirement, the contract must either provide for the carrier to earn a minimum of \$1,000 per month delivered transportation services, or the contract must call for substantial shipper obligations not normally provided under common carrier tariff rates by any carrier. Merchants of California filed special contract numbers T-172,716-1 through 394 indicating various shippers (see attached appendix), which appeared on the Commissions Transportation Calendars on January 14, 16, 17, 22, and 23 of 1992 and was suspended for 30 days because they did not include evidence of substantial shipper obligation required by Rule 6.14 of General Order 147-C.

This order issued FEB 05 1992, by the Public Utilities Commission of the State of California by the adoption of the Resolution OCR-1040 of which this order is a part.
