
Conclusion of Law




In conformity with the findings and order made by the Commission in a resolution entered this day, Peeters Transportation Co., Inc. is ordered to cancel Local Freight Tariff No. 1, CA PUC 1, in its entirety, before July 16, 1992.

The filing cannot be accepted, as filed, because a) the authority cited for its publication is incorrect, b) the effective date is earlier than the calendar date, c) the tariff is not cross-reference to other tariffs in which the carrier issue, concur or participate, and d) no authority to increase the rates is cited.

The filing was listed on the Commission's Daily Transportation Calendar on June 9, 1992 and was suspended for 30 days effective June 15, 1992.
