In conformity with the findings and order made by the Commission in a resolution entered this day, Special Contract T-147,723-8 with Synergistic Performance Corporation is ordered canceled and will not go into effect on January 3, 1993.

Special contracts must include evidence of substantial shipper obligations in the contract. To meet this requirement, the contract must either provide for the carrier to earn \$1,000.00 per month for delivered transportation services, or the contract must call for substantial shipper obligations not normally provided under common carrier tariff rates by any carrier.
