R E S O L U T I O N

RESOLUTION GRANTING VOLUNTARY SUSPENSION OF PASSENGER
STAGE CORPORATION CERTIFICATE OF PUBLIC CONVENIENCE
AND NECESSITY HELD BY CALIFORNIA PACIFIC COAST TOURS,
INC., PSC-1170

California Pacific Coast Tours, Inc., of Felton, California, holds a certificate of public convenience and necessity as a passenger stage corporation (PSC-1170) for the transportation of passengers and their baggage between certain designated points in Orange County, Los Angeles County, on one hand, and the San Francisco Area, on the other hand. The certificate was acquired pursuant to Decision 93745 dated November 13, 1981 in Application 60166.

On April 25, 1986, California Pacific Coast Tours, Inc. requested voluntary suspension of PSC-1170 until June 25, 1987 because of the following reason: 1) death of the president; 2) corporate reorganization; 3) inactive nature of the route.

In these circumstances, the Commission finds that public convenience and necessity do not require the service of this carrier at this time.

IT IS ORDERED that:

1. The certificate of public convenience and necessity as a passenger stage corporation (PSC-1170) which was acquired by California Pacific Coast Tours, Inc., pursuant to Decision 93745, dated November 13, 1981 in Application 60166, is hereby suspended until June 25, 1987.
2. California Pacific Coast Tours, Inc., is authorized and directed to file suspension supplements to the tariffs and timetables on file with the Commission.

3. Prior to the resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filings shall be made not less than five days' notice to the public and to the Commission.
4. The authority to suspend operations granted herein shall expire on June 25, 1987 upon earlier resumption of service, which may be effected upon compliance with the Ordering Paragraph 3 above.
5. California Pacific Coast Tours, Inc. is placed on notice that commencement of operations under the certificate referred to herein prior to compliance with Ordering Paragraph 3 and 4 may be cause for further suspension or revocation of its operating authority.
