R E S O L U T I O N

RESOLUTION TO MODIFY AND ADD RULES COVERING FREE
BAGGAGE LIMITS, CHARGES FOR BAGGAGE OVER THE FREE
LIMIT, AND CHARGES FOR DELAYS ON SPECIAL SCHEDULE
SERVICE OF TRAVIS EXPRESS INC. (PSC 1381)

Travis Express Inc., (PSC-1381) has filed with the Commission a request for authority to make the following modifications and additions to its current Tariff Rules and Regulations, CPUC No. 1

1. To add to Paragraph 5 the following provisions:

In addition to hand-carried baggage taken by the passengers personally onto the bus, there shall be no charge for the first two pieces of baggage per fare-paying passenger checked with the driver. For each additional item of baggage checked with the driver, there shall be a charge of \$6.00 per additional piece.

2. To add the following provisions as Paragraph 6:

6. Carrier will operate special schedules of its service when appropriate advanced request is made. In the event that the departure of such a special schedule is delayed through no fault of the carriers, the party requesting the special schedule shall be charged \$30.00 for each hour or part of an hour of delay when the departure is not made within thirty minutes of the requested special schedule departure time.

Travis claims the requested addition to Paragraph 5 will allow it to control excessive costs because some passengers attempt to transport "huge" (more than two) quantities of baggage with them. These attempts increase costs by delaying vehicle departures, and by reducing available passenger capacity.

Similarly, the purpose of Paragraph 6 is to compensate Travis for excessive delays (more than 30 minutes) in departure time of pre-arranged "special" schedules. These delays increase costs by increasing vehicle idle time and driver standby expenses.

IT IS ORDERED that:

1. Travis Express Inc., is authorized to modify Paragraph 5 of and add Paragraph 6 to its current tariff and Regulation, CPUC No. 1.

Tariffs shall be filed not earlier than the effective date of this order. They may go into effect 5 days or more after the effective date of this order on not less than 5 days' notice to the Commission and to the public.

2. The authority shall expire unless exercised within 90 days after the effective date of this order.


This action is taken in compliance with Resolution TS-660, adopted by the Commission August 7, 1984.
