WHEREAS: The California Department of Insurance has informed the Commission that it has no financial, operational, or organizational information of any kind concerning ICA, whether it is licensed or certificated in any state of the United States, or whether any such existing license is currently in good standing, and has no reliable information concerning the domicile of this particular company; and

WHEREAS: The California Department of Insurance has informed the Commission that there is nothing to justify the employment of ICA as a security for the underwriting of any California risk; and

WHEREAS: The California Department of Insurance has advised the Commission to reject any further Certificates of Insurance identifying Insurance Corporation of America as the underwriting carrier and based on the foregoing has suggested the Commission rescind any such Certificates of Insurance which may be outstanding; and

WHEREAS: It is necessary for the protection of the public that Certificates of Insurance on file with the Commission be issued by insurance companies that are acceptable to the California Department of Insurance,

THEREFORE, IT IS ORDERED that:

1. The operating authorities of the above noted charter-party operators are suspended effective today.

- 2. The Executive Director may reinstate any operating authority suspended pursuant to this resolution provided suitable evidence of insurance is filed with the Commission.
- 3. The Executive Director shall revoke any of the above noted operating authorities if a suitable evidence of insurance is not filed with the Commission within 90 days of the effective date of this resolution.
- 4. The Executive Director shall serve this resolution by mail on each of the above noted charter-party operators.
