## RESOLUTION

RESOLUTION GRANTING VOLUNTARY SUSPENSION OF PASSENGER STAGE CORPORATION CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY HELD BY OLINTO LINDY BELLETTINI AND DOROTHY FRANCES BELLETTINI, DBA LINDY'S LINO SERVICE, PSC-1393.

Olinto Lindy Bellettini and Dorothy Frances Bellettini (Belletini), doing business as Lindy's Limo Service, hold a certificate of public convenience and necessity as a passenger state corporation (PSC-1393) for the transportation of passengers and their baggage between General Fox Airport, Edwards Air Force Base, and the Lancaster/Palmdale Service Area. The certificate was granted by Decision 85-05-085 in Application 84-10-066.

On January 7, 1988, Bellettini requested voluntary suspension of PSC-1393, citing illness as the reason for the request.

In these circumstances, the Commission finds that public convenience and necessity do not require the service of this carrier at this time.

## IT IS ORDERED that:

- 1. The certificate of public covenience and necessity as a passenger stage corporation (PSC-1393) which was granted to Olinto Lindy Bellettini and Dorothy Frances Bellettini dba Lindy's Limo Service by Decision 85-05-085, dated May 15, 1985, in Application 84-10-066 is hereby suspended for the period of one year commencing on the effective date of this resolution.
- 2. Bellettini is authorized and directed to file suspension supplements to the tariffs and timetables on file with the Commission.
- 3. Prior to the resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days' notice to the public and to the Commission.

- 4. The authority to suspend operations granted herein shall expire one year from the effective date of this resolution or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 3 above.
- 5. Olinto Lindy Bellettini and Dorothy Frances Bellettini are placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 3 and 4 may cause further suspension or revocation of their operating authority.
