ORDER INSTITUTING RULEMAKING

In 1981, in Decision (D.) 93251 (6 CPUC 374), the Commission established the Advocates' Trust Fund (Fund) with money received in a settlement from the Pacific Telephone and Telegraph Company (now Pacific Bell). The Commission intended the Fund to reimburse parties who represent consumer interests in quasi-judicial complaint cases before it.

D.93251 created the Fund with \$164,900. As of June 30, 1991, the Fund was worth \$268,614. In the decade since its creation, it has disbursed \$85,273 to qualifying parties.

Currently, the Fund denies reimbursement of fees to a single ratepayer who litigates to avoid paying a large but unjust fee because that ratepayer's economic interest alone suffices to motivate his or her participation.

The Commission staff has suggested making the following change to Paragraph 1.4 of the Advocates' Trust Fund:

"1.4 An award will be based upon consideration of ~~three~~ four factors: (1) the strength or societal importance of the public policy vindicated by the litigation, (2) the necessity for private enforcement and the magnitude of the resultant burden on the complainant, and (3) the number of people standing to benefit from the decision, and (4) the magnitude of the party's own economic interest in the

litigation. No award will be made without a specific finding by the CPUC of what would be a reasonable amount for advocates' attorneys', or expert witness fees, in view of the time spent, expenses proven, level of skill shown, and comparable fees paid to others practicing public utility law. ~~No award should be made where a party's own economic interest is sufficient to motivate participation."~~

The Commission adopted the last sentence of this paragraph ("No award should be...") at the suggestion of the Natural Resources Defense Council, because this test would preclude "substantial customers of utility services or parties seeking to preserve or obtain some competitive position" from reimbursement. The proposed change would allow fee recovery to some of these parties if the Commission found good cause for it. Under the proposed language, the Commission would have more discretion to award fees from the Fund.

This order will solicit comments on or exceptions to the proposed change.

IT IS ORDERED that:

1. A rulemaking is hereby instituted on the Commission's own motion for the purpose of changing the Advocates' Trust Fund to require the Commission to consider a party's economic interest in a proceeding before awarding fees, and to allow the Commission to grant compensation to parties at its own discretion even when the parties' own economic interests are sufficient to motivate participation.

2. The Executive Director shall mail copies of this order to an extensive list of public utilities and attorneys practicing before this Commission. Such list shall be compiled from service lists in recent major Commission proceedings. The Executive Director shall provide further notice of this proceeding by printing notice of this order in bold face type in the Commission's

Daily Calendar on each of 15 business days from the effective date of this order.

3. Interested persons are invited to submit comments on or exceptions to the proposed change to Advocates' Trust Fund by filing with the Commission's Docket Office no later than October 23, 1991. Such filings shall conform to the Commission's rules.

4. Those who wish to be included on the initial service list of this proceeding and thereby receive the full text of the filed comments, shall send a letter to the Commission's Process Office, 505 Van Ness Avenue, San Francisco, CA 94102 by September 30, 1991, containing such request. Thereafter, the Process Office will compile the initial service list, and transmit it to the parties in advance of the October 23, 1991 filing date.

This order is effective today.
