R E S O L U T I O N

MODIFYING THE REQUIREMENTS OF ORDERING PARAGRAPH 3 OF
DECISION 84582 AS MODIFIED BY THE THIRD INTERIM OPINION,
DECISION NO. 85778, THE 8th INTERIM OPINION, DECISION
87377 AND THE 13th INTERIM OPINION, DECISION 91208

Paragraph 3 of Decision 84582 as modified above requires BART to submit to the Commission staff the following reports at the indicated intervals:

- a. Car Weekly Summary, Form No. 0742 - file weekly
- b. Monthly failure reports for vehicles, central control and station wayside equipment - file monthly
- c. Daily schedules of service level indicating average number of trains in revenue service and the time period that the schedules shall be maintained. When the number of trains scheduled for a time period of two hours or longer is greater or less than 7 percent of any other schedule, it is defined as a new service level.
- f. Daily number of bad order trains for each service level noted in c. - file weekly.
- g. Daily number of passenger off-loads for each service level noted in c. - file weekly.
- i. Weekly total of car and train hours - file weekly.
- j. 'Categories listed on car report'. This report shall include a plot of the weekly average of "A" car availability - file monthly.
- k. Central Supervisors Daily Log - file daily.

BART submits several separate reports to the Commission staff in response to these requirements. Subsequent to the date of the Third Interim Opinion, BART instituted a report entitled the, "Daily Operations Performance Report," which duplicates the information in the required reports except for the information required by Subparagraph c and k which is provided in the Central Supervisor's

Log. The Daily Operations Performance Report and Central Supervisor's Log, as well as the individual reports, continue to be sent to the Commission staff.

By letter dated 12-30-87, BART has requested that submission of the Daily Operations Performance Report be substituted for the reports required by the above-referenced Ordering subparagraphs.

Staff has reviewed this request and has ascertained that the Daily Operations Performance Report contains the required data to be substituted for those reports required by Ordering Subparagraphs a, b, c, f, g, i, j, of Decision 84582 as modified above.

IT IS ORDERED THAT:

Ordering Paragraph 3 of Decision No. 84582 is amended to read as follows:

- "3. One copy of the following San Francisco Bay Area Rapid Transit District operating documents shall be filed with the Commission staff at the indicated intervals until further order:
 - a. Daily Operations Performance Report. - file daily
 - b. Central Supervisor's Daily Log - file daily

This resolution is effective today.
