SUBJECT: Order revoking Certificates of Public Convenience and Necessity which have been abandoned by interLATA telecommunications common carriers. Resolution No. T-10994.

WHEREAS: By various decisions issued by the Public Utilities Commission during 1984 and 1985 several interLATA telecommunication common carriers have been granted Certificates of Public Convenience and Necessity to provide interLATA telecommunications services to the public, and

WHEREAS: Budget-Tel Corporation in Application 84-02-47 filed February 24, 1984 was granted a CPC&N March 21, 1984 by Decision 84-03-058;

WHEREAS: AIT Corporation in Application 84-05-037 filed May 10, 1984 was granted a CPC&N July 5, 1984, by Decision 84-07-080; and

WHEREAS: Budget-Tel Corporation and AIT Corporation have failed to respond to numerous communications by mail and such mail has been returned to the Commission marked "Moved left no address". The Communications staff has attempted to contact both companies by telephone. The staff discovered both companies service had been disconnected with no new service installed. Correspondence was sent to Pacific Bell asking for confirmation of these disconnected numbers. Budget-Tel Corporation services were disconnected during April, 1985, and there is no forwarding address. AIT Corporation was disconnected for non-payment of delinquent bills during May, 1985, and there is no forwarding address.

WHEREAS: Budget-Tel Corporation and AIT Corporation cannot be reached and have apparently abandoned their locations. Staff has requested that their Certificates of Public Convenience and Necessity be revoked.

The Commission finds that the authority granted by D.84-03-058 for Budget-Tel Corporation and D.84-07-080 for AIT Corporation should be revoked because of the information appearing in the previous paragraph indicating abandonment; and good cause appearing,

IT IS ORDERED that:

(1) The operating authority granted to Budget-Tel Corporation by D.84-03-058 and AIT Corporation by D.84-07-080 is revoked and tariff schedules are cancelled.

(2) Budget-Tel Corporation and AIT Corporation are no longer designated as service suppliers as defined in Part 22, Chapter 1, Section 44016 of the Revenue and Taxation Code.


(3) Budget-Tel Corporation and AIT Corporation are no longer subject to the user fee as a percentage of gross intrastate revenue pursuant to Public Utilities Code Sections 431-435.

(4) A copy of this Resolution shall be placed in the formal files of A.84-02-47 and A.84-05-037.

The effective date of this Resolution is today.
