SUBJECT: Executive Mobile Systems, Ltd. Order revoking the Certificate of Public Convenience and Necessity granted by D.86-02-011. Resolution No. T-11064.

WHEREAS: EXECUTIVE MOBILE SYSTEMS, LTD., was granted a Certificate of Public Convenience and Necessity to operate as a reseller of cellular radio telecommunications services within California on February 5, 1986, by Decision 86-02-011 in Application 85-11-007; and

WHEREAS: Executive Mobile Systems, Ltd., has failed to respond to various correspondence by mail including one sent certified mail on June 10, 1986. Attempts to contact this company by telephone have been to no avail since the number as listed is disconnected. Staff counsel called the attorney who filed Application 85-11-007. That attorney stated he no longer represents Executive Mobile Systems, Ltd. or its principal and managing partner, Robert Neral. Therefore, staff has requested that Certificate of Public Convenience and Necessity for Executive Mobile Systems, Ltd. be declared abandoned and be revoked.

The Commission finds that the authority granted by D.86-02-011 for Executive Mobile Systems, Ltd. has been abandoned and should be revoked pursuant to the information stated above; and good cause appearing,

IT IS ORDERED that:

(1) The operating authority granted to Executive Mobile Systems, Ltd. by D.86-02-011 is revoked and filed tariff schedules are cancelled.

(2) Executive Mobile Systems, Ltd. is no longer designated as a service supplier as defined in Part 22, Chapter 1, Section 44016 of the Revenue Taxation Code.

(3) Executive Mobile Systems, Ltd. is no longer subject to the user fee as a percentage of gross intrastate revenue pursuant to Public Utilities Code Sections 431-435.

(4) A copy of this Resolution shall be mailed by certified mail to Executive Mobile Systems, Ltd. at its last known address.

(5) A copy of this Resolution shall be placed in the formal files of A.85-11-007.

The effective date of this Resolution is today.
