SUBJECT: American Paging, Inc. (of California) (U-2001-C). Order authorizing certain rate increases for radio paging services in the San Diego area. Estimated annual increase in billing is \$22,500. Resolution No. T-11076.

WHEREAS: AMERICAN PAGING, INC, (OF CALIFORNIA), by Advice Letter No. 18, filed October 1, 1986, requests authority under Section 454 of the Public Utilities Code to make effective the following tariff revisions:

To increase paging service rates in the San Diego area as follows:

Tone-only: from \$10 to \$10.50 for 1 - 3 units, per month
from \$9 to \$9.50 for 4 - 10 units, per month

Tone-voice: from \$17 to \$18 for 1 - 3 units, per month
from \$16 to \$17 for 4 - 10 units, per month

Numeric

Display: from \$13 to \$14 for 1 - 3 units, per month
from \$12 to \$13 for 4 - 10 units, per month

The proposed increases reflect increased costs in providing these services. The proposed rates are the same as those now charged by the utility in San Francisco and Sacramento. The estimated annual billed revenue increase is \$22,500 or about 2.2%.

Customers on one-year contract will not have the increases applied until expiration of their contracts. Notice to all customers was given on or before October 1, 1986, and no protests have been received.

The Commission finds that the rates, charges and conditions authorized in this resolution are just and reasonable and present rates, charges and conditions, as they differ from the rates, charges and conditions authorized in this resolution are for the future unjust and unreasonable; and good cause appearing;

IT IS ORDERED that:

(1) Authority is granted to make the above revisions effective on November 15, 1986.

(2) Schedule Cal. PUC No. 2-T, 4th Revised Sheet No. 6 shall be marked to show that such sheet was authorized by Resolution of the Public Utilities Commission of the State of California No. T-11076.

The effective date of this Resolution is today.
