R E S O L U T I O N

PACIFIC BELL. ORDER AUTHORIZING A REVISION OF SCHEDULE CAL. P.U.C. NO. 175 - T, ACCESS SERVICE, TO PROVIDE A SPECIALIZED SERVICE ARRANGEMENT (SSA) ENTITLED UNIVERSAL LINE LEVEL MAINTENANCE (ULLM) TO MCI TELECOMMUNICATIONS (MCI) ON LESS THAN REGULAR NOTICE.

Pacific Bell (Pacific) has filed Advice Letter No.15230 on March 3, 1987, seeking authorization under Section 454 of the Public Utilities Code to provide Universal Line Level Maintenance service (ULLM) to MCI on less than regular notice because MCI Telecommunications (MCI) has stated a need to have the information provided by ULLM as soon as possible.

ULLM will provide a one-time listing of information on Pacific Bell business customers from Pacific's billing information records. The information provided will be:

- * Carrier Identification Code (for MCI Accounts only)
- * Billing Telephone Number (Published only)
- * Customer Code
- * Working Telephone Number (Published only)
- * Hunting Multiline
- * Terminal Number
- * Customer Type (Business only)
- * Non-published Indicator
- * Line indicator (Single/multi)
- * Account Name
- * Account address
- * Zip Code
- * Serving Wire Center Code

This information will provide MCI a means to verify the presubscription of business customers to its long distance service. MCI will also use the information to settle customer billing disputes, validate customer billings, evaluate present and future markets, and disseminate information on carrier related services and rate availability. In addition, MCI also expects to improve its order submission process to Pacific.

Such information has been available to MCI on an central office by central office basis as conversion to equal access was completed. This will be the first time MCI has received the information for all of Pacific's business customers at one time. AT&T has access to such information through its contract with Pacific for billing and collection services.

The contract between MCI and Pacific states that Pacific will not release information provided by ULLM to MCI, "unless MCI has tariff rules on file with the CPUC substantially identical to those which govern the exchange carriers' release of non-published information or customer credit information, as described in Schedule Cal. P.U.C. No. A2...[Rules No.34 and 35]." MCI filed this tariff provision on March 3, 1987 to be effective concurrently with this ULLM filing.

The Commission finds that the rates, charges and conditions authorized in this Resolution are just and reasonable, and good cause appearing,

IT IS ORDERED that:

(1) Authority is granted to make the above revision effective on March 26, 1987.

(2) Schedule Cal P.U.C. No. 175-T, 59th Revised Sheet 1, 24th Revised Sheet 1-I, and original sheets 587-Z-12 through 587-Z-20 shall be marked to show that such sheets were authorized by Resolution of the Public Utilities Commission of the State of California No. T-12012.

This resolution is effective today.
