R E S O L U T I O N

PACIFIC BELL. ORDER AUTHORIZING THE PROVISION OF FIBER OPTIC SERVICE TO APPLE COMPUTER ON LESS THAN REGULAR NOTICE PURSUANT TO SECTION V.B. OF GENERAL ORDER 96-A.

SUMMARY

This resolution authorizes Pacific Bell's Advice Letter No. 15365 as supplemented by Advice Letter No. 15365A to be effective on less than the regular notice of 40 days.

BACKGROUND

On March 21, 1988 Pacific Bell filed Advice Letter No. 15365 with associated Schedule Cal. P.U.C. No. B3 tariff sheets to cover the offering of fiber optic service to Apple Computer. According to normal tariff filing procedures this Advice Letter would become effective in 40 days.

On March 29, 1988, Pacific Bell, in response to Apple Computer's request for an escalated installation date to meet the company's internal schedule, filed an Advice Letter Supplement No. 15365A requesting the filing to be effective on less than the regular notice of 40 days. The revised effective date is April 14, 1988.

The tariff proposal for this filing was reviewed by the Commission Advisory and Compliance Division staff. This service is provided above cost and will not be a burden to the general ratepayers.

FINDINGS

1. A shorter than regular notice period for Advice Letter No. 15365 is required to allow Pacific Bell to meet the needs of its customer Apple Computer in a timely manner.
2. This matter did not appear on the Commission's public agenda. We find that failure to act on this resolution by April 13, 1988 may affect Pacific Bell's ability to provide the service discussed above. Such an emergency justifies our action today under Section 306(b) of the Public Utilities Code.

IT IS ORDERED that:

- (1) Authority is granted to allow Advice Letter No. 15365 as supplemented by Advice Letter No. 15365A to be effective on less than regular notice, on April 14, 1988, pursuant to Section V.B. of General Order 96-A.
- (2) Schedule Cal. P.U.C. B3 1st Revised Sheet 272.36 shall be marked to show that this sheet was authorized by Resolution of the Public Utilities Commission No. T-12081.

The effective date of this resolution is today.
