RESOLUTION

GTE CALIFORNIA INCORPORATED (GTEC). ORDER AUTHORIZING A PRICE INCREASE IN THE SAN FERNANDO STREET ADDRESS DIRECTORY AT AN ESTIMATED ANNUAL BILLING INCREASE OF APPROXIMATELY \$49,000.

SUMMARY

This resolution authorizes GTEC to increase Street Address Directory rates in the San Fernando Street Address Directory due to the inclusion of the Lancaster Exchange not previously listed in the San Fernando Directory resulting in an increase in the billing of approximately \$49,000.

BACKGROUND

By Advice Letter No. 5174 filed October 19, 1988, GTEC requests authority to increase the amount charged for the San Fernando Street Address Directory.

Street Address Directories are an optional service that provides a directory of telephone listings in "reverse order," listing them alaphanumerically by street address rather than by subscriber names as in the white pages (Note: no unlisted numbers or addresses are included). These directories are used by insurance companies, door-to-door sales organizations, and collection agencies.

Due to the high degree of community of interest between these exchanges, GTEC proposes to include High Vista, Lake Hughes and Lancaster Exchanges into the existing San Fernando Street Address Directory. Currently, Lancaster, High Vista and Lake Hughes are not included in any street address directory.

Street Address Directory rates are established according to the number of listings as shown on table from GTEC Schedule Cal. P.U.C. No. D-1, sheet 3:

GTEC seeks authority to increase the monthly rate for the San Fernando Street Address Directory from \$7.40 per month (Rate Group 5) to \$8.80 per month (Rate Group 7), due to the inclusion of the Lancaster Exchange not previously offered in the San Fernando Directory increased listing count of 81,233, which qualifies San Fernando for the application of Rate Group 7.

FINDINGS

GTEC has met the minimum subscriber count to qualify for application of Rate Group 7 rates for subscribers to the San Fernando Street Address Directory.

IT IS ORDERED that:

(1) GTEC's request for authority to increase rate groups for the San Fernando Street Address Directory is granted. The above revisions are effective November 10, 1988. (2) All tariff sheets filed under Advice Letter No. 5174 shall be marked to show that such sheets were authorized by Resolution of the Public Utilities Commission of the State of California Resolution No. 13028.
