GENESIS COMMUNICATIONS INC., COMMAR INC., SOUTHWEST INTERCONNECT, COASTAL TELEPHONE NETWORK, COMPUTE-A-CALL INTERNATIONAL INC., VALNET, TELECOM CELLULAR, LONG DISTANCE AMERICA, HEMET, INC., NEVADA SUPERPHONE (SUPERPHONE CORP.), NETWORK MICROWAVE INC., ARGO COMMUNICATIONS CORPORATION, AND UNITEL; ORDER REVOKING THE CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY GRANTED BY DECISION NOS. 86-05-080, 86-03-048, 84-02-012, 87-05-056, 85-08-023, 84-09-012, 87-10-076, 86-08-069, 85-11-011, 85-12-056, 84-012-005, AND 85-12-059 RESPECTIVELY RESOLUTION NO. 13057.

SUMMARY

Order revoking Certificates of Public Convenience and Necessity for the following intrastate interLATA telecommunication common carriers:

Genesis Communications Inc. was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application 86-03-034 by Decision 86-05-080.

Commar Inc. was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application 85-12-057 by Decision 86-03-048.

Southwest Interconnect, was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application 84-01-061 by Decision 84-02-012.

Coastal Telephone Network, was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application 87-03-042 by Decision 87-050-056.

Compute-A-Call International Inc., was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application 85-06-018 by Decision 85-08-023.

Valuet was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California by from Application 84-07-015 by Decision 84-09-012.

Telecom Cellular was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application No.87-07-037 by Decision 87-10-076.

Long Distance America, Hemet, Inc., was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application No. 86-06-046 by Decision 86-08-069.

Nevada Superphone (Superphone Corp.) was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application No. 85-08-049 by Decision 85-11-011.

Network Microwave Inc. was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application No. 85-09-029 by Decision 85-12-056.

Argo Communications was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application No. 84-10-017 by Decision 84-12-005.

Unitel was granted a Certificate of Public Convenience and Necessity to operate as a reseller of long distance telephone service within California from Application No. 85-09-053 by Decision 85-12-059.

Pacific Bell and GTB-California have letters on file with this Commission stating that the Interexchange Companies (IEC) listed above no longer have local telephone service. Additionally these companies have had mail returned to the Public Utilities Commission for a, "Second and Final Notice of Delinquent Annual Report". This report requires IEC's to file annual financial statements to the Public Utilities Commission per Section 2107 and 2108 of the Public Utilities Code. Failure to file this report may result in a penalty of up to \$2,000 per day. Other mail to these companies have been returned to the Public Utilities Commission marked as follows, "Moved left no Address,""Box closed-No order, ""No forwarding order on file, and unable to forward,". Commission Advisory and Compliance Division (CACD) has attempted to reach these companies by telephone, but has reached disconnected numbers. Because of the above mentioned evidence, the Commission concludes that telephone companies listed above are no longer doing business in California.

Therefore the CACD staff requests that the Certificates of Public Convenience and Necessity previously issued by this Commission for the above mentioned companies be revoked.

FINDINGS

It is reasonable to conclude that the following companies are no longer doing business in California; Genesis Communications Inc., Commar Inc., Southwest Interconnect, Coastal Telephone Network, Compute-A-Call International Inc., Valnet, Telecom Cellular, Long Distance America, Hemet, Inc., Nevada Superphone (Superphone Corp.), Network Microwave Inc., Argo Communications Corporation, and Unitel. The above listed companies authority should be revoked.

IT IS ORDERED that:

- (1) The operating authority granted to Genesis Communications Inc., Commar Inc., Southwest Interconnect, Coastal Telephone Network, Compute-A-Call International Inc., Valuet, Telecom Cellular, Long Distance America, Hemet, Inc., Nevada Superphone (Superphone Corp.), Network Microwave Inc., Argo Communications Corporation, and Unitel by Decision Nos. 86-05-080, 86-03-048, 84-02-012, 87-05-056, 85-08-023, 84-09-012, 87-10-076, 86-08-069, 85-11-011, 85-12-056, 84-012-005, 85-12-059 respectively is revoked.
- (2) Genesis Communications Inc., Commar Inc., Southwest Interconnect, Coastal Telephone Network, Compute A-Call International Inc., Coastal Telephone Network, Valuet, Telecom Cellular, Long Distance America, Hemet, Inc., Nevada Superphone (Superphone Corp.), Network Microwave Inc., Argo Communications Corporation, and Unitel are no longer subject to the user fee as a percentage of gross intrastate revenue pursuant to Public Utilities Code Sections 431-435.
- (3) A copy of this resolution shall be placed in the formal files of Application Nos. 86-03-034, 85-12-057, 84-01-061, 87-03-042, 85-06-018, 84-07-015, 87-07-037, 86-06-046, 85-08-049, 85-09-029, 84-10-017, 85-09-053.
- (4) The telecommunication tariffs of the aforementioned firms are cancelled. The CPUC Corporate Identification Numbers of these firms are also cancelled and will not be reissued.
- (5) The effective date of this resolution is May 11, 1989.
